The following candidates are hereby appointed temporarily to officiate as “System Assistant” in the Court’s Establishment in PB – 2 - Scale of Pay of ₹ 9,300 - 34,800/- and Grade Pay of ₹ 4,200/- and D.A. & other allowances as sanctioned by the State Government from time to time.

They shall remain in probation for a period of 2 (two) years from the date of their joining the service. Their services are subject to the following terms and conditions.

1. The appointments are purely temporary and terminable at any time without prior notice and assigning any reason thereof.
2. The appointees should join in their new assignment on **01.10.2016** failing which their appointment shall be automatically cancelled.
3. They should furnish the following documents at the time of joining.
 - (a) “Attestation Form” in duplicate duly filled in along with two passport size photographs duly attested by a Gazetted Officer.
 - (b) Medical Certificate of fitness from an authorised Medical Officer not below the rank of Assistant Surgeon.
 - (c) Two Character Certificates from two Gazetted Officers.
 - (d) Declaration to the effect that they have not been dismissed from any Govt. service.
 - (e) Declaration to the effect that they have not more than one spouse living in case they are married.
 - (f) Certificates in support of their date of birth, caste, educational qualification, technical qualification etc. and Mark Sheets, in original along with their copies duly attested.
