Dash and Hon'ble Shri Justice Biswanath Rath will sit in Division Bench through Video Conferencing at 11.00 A.M.; and Hon'ble Shri Justice Biswanath Rath will sit Single in Court No.XXII (1st Floor) after rising of the Division Bench.
