- d. be able to speak, read and write Odia and have passed a test in Odia equivalent to the M.E. Standard;
- e. be of good character;
- f. be of sound health, good physique and free from organic defects or bodily infirmity;
- g. have not more than one spouse living, if married; and
- h. have paid the fees prescribed for the examination.
