OFFICE ORDER

Cuttack, Dated, the 04th JULY, 2020

It is hereby notified that in view of the office order dated 04.07.2020 of the Commissioner, Cuttack Municipal Corporation declaring shutdown in the entire jurisdiction of the Cuttack Municipal Corporation area till 08.07.2020, the High Court and its offices shall remain closed till 08.07.2020.

Consequently, the High Court will not function from 06.07.2020 to 08.07.2020.
