As directed, the system of pagination shall be effective in all new cases which shall be filed from 04.01.2021 onwards. Any pleading, affidavit, document, rejoinder etc filed in the new cases on or after the aforementioned date must be in consonance with the previous page number of the pagination.

In order to know the last used page number and next available page number, learned Counsel/ Parties may check the 'Case Status' of the concerned case in the Court's website. A step by step guide in this regard containing the relevant screenshots is annexed herewith for reference.



1. Pagination status of cases can be viewd from "Orissa High Court web site". Url:- https://www.orissahighcourt.nic.in/




2. Give case type/case number/ case year and captcha to view case details with pagination information.
