## Recruitment to the post of Consultant, Law and Consultant, History for the Centre for Judicial Archives of Odisha, Cuttack

Applications in prescribed format are invited for 01 (One) post of Consultant, Law and 01 (One) post of Consultant, History for the Centre for Judicial Archives of Odisha, Cuttack from in-service Professors on deputation basis and from retired Professors in the respective disciplines.

#### 1. WORK PROFILE

The Centre for Judicial Archives of Odisha has been established by the Government of Odisha, Home Department Notification No. 14380 dated 1st May, 2022 for documentation of judicial history of the State. The Consultant, Law and the Consultant, History will work for judicial history project in coordination with the Director-cum-Officer on Special Duty of the Centre. The work involves research into the old judicial records of the High Court and the District Courts of the State.

## 2. GENERAL TERMS AND CONDITIONS

- (a) The engagement in respect of in-service Professors shall be on deputation basis for a period of 02 (two) years and in respect of retired Professors shall be on purely temporary and contractual basis for a term of 02 (two) years terminable by one month's notice.
- (b) The person applying for the said posts shall not be below 45 years and beyond 68 years of age as on the date of publication of the advertisement on the Court's website.

#### 3. ELIGIBILITY CRITERIA

Consultant, Law: The candidate, who is an in-service or retired Professor, should be a post-graduate in Law and should have experience of teaching in Law for at least 10 (ten) years in any recognized College or University. Ph.D. degree with thesis in Indian constitutional/legal history would be an added advantage. History as one of the subjects in graduation level would also be an added advantage.

Consultant, History: The candidate, who is an in-service or retired Professor, should be a post-graduate in History and should have experience of teaching in History for at least 10 (ten) years in any recognized College or University. Specialization in Indian constitutional/legal history, and/or expertise in deciphering Persian manuscript and/or Odia Karani script would be an added advantage.

#### 4. REMUNERATION:

- (i) The pay in case of in-service candidates will be considered as per the Pay and Allowances along with other perks and privileges attached to the said posts.
- (ii) The remuneration in case of retired candidates will be considered by adopting the principle of 'pay minus pension' or Rs.1,00,000/- (Rupees One Lakh) only per month whichever is less.
