- 2) Two separate sealed envelopes should be used for submitting 'Earnest Money Deposit' and 'price quotation' respectively, subscribing on the envelopes (a) Earnest Money for disposal of Condemned Metal Furniture and other misc. Items and (b) Sealed Quotation for sale of condemned Metal furniture and other misc. items as per Annexure 'B', addressed to the Registrar (Judicial), High Court of Orissa. The sealed envelopes shall be received latest by 23.10.2024 till 3:00 pm at High Court of Orissa which will be opened on the very next day i.e. on 24.10.2024 at 4:00 p.m. in presence of quotationers or their authorised representative, if they want to be present in the chamber of the Assistant Registrar (Administration).
- 3) The representatives of the quotationers who would like to participate in the opening should inform in advance regarding their participation, so that their entry in the premises of the High Court is regularised. They should also bring their valid identity card etc. for the purpose.
- 4) No quotation either by post or by hand shall be received after the specific time and date mentioned above. No extension of date and time shall be allowed.
