1. Paintings will be supplied by the Court and captions of the Paintings will be printed at the bottom of the Paintings.

- (ii) The inner pages with six sheets shall be of 170 GSM JK/ Imported Art Paper. One painting (Showing achiever's name and details at bottom left and name of the month & year at bottom right) in each page (12 photos in 6 sheets) will be printed on the top portion with the logo of High Court of Orissa along with a caption namely "JUDICIAL CALENDER OF ODISHA" and the bottom portion of each page will show Calendar of one month for both 'High Court of Orissa' and 'Civil & Criminal Court' along with a footnote displaying "Selected from \_\_\_\_ paintings on the theme 'RIGHTS OF CHILDREN WITH DISABILITIES' painted by school children of classes VII to X in the painting competition organized by the District Courts of Odisha on 10th November, 2024."

- 4. The Sundays and other holidays should be printed on the Calendar in red color.
- 5. Rate should be quoted **inclusive of all taxes**.

- 6. The Calendar shall be delivered to the Store and Purchase Section of High Court of Orissa, Cuttack free of transportation cost.
- 7. Each calendar must have a Fabrication Spiral binding of 17" long with an iron stick and back supporting pulp board of 2".
- 8. The Design and the inner contents of the Judicial Calendar may be subject to change as per requirement of the Court which the successful bidder shall have to carry out.
- 9. The calendar shall reach us within 15 days of the date of issue of the work order.

- 11. Due to paucity of time, Court may call for Price quotation of sole eligible bidder if no other bidder is found suitable for the work.
