THE POST OF LAW RESEARCHER (HISTORY) FOR THE CENTRE OF JUDICIAL ARCHIVES OF
ODISHA, CUTTACK PURSUANT TO ADVERTISEMENT NO. 01/2025**

The examination for selection to the post of Law Researcher (History) for the Centre of Judicial Archives of Odisha, Cuttack pursuant to Advertisement No. 01/2025 will be held in two stages viz. Written Test & Interview. The Written Test shall be of 2 (two) hours duration for 100 marks. The minimum qualifying mark in the Written Test is 40% of the total marks. Those candidates who qualify the Written Test shall attend the Interview. The interview shall be of 50 marks and the minimum qualifying mark is 40% thereof. The marks secured by the candidates in the Written Test shall be added to the marks secured by them in the Interview to arrive at the total mark and the merit list shall be prepared on the basis of such total marks.

The following candidates are provisionally found eligible to appear in the Written Test to be held on **25.02.2025** from **10.00 AM to 12.00 NOON** in the New Conference Hall of the old building of High Court of Orissa.


