The selection shall be held in two stages viz. Written Test & Interview. The Written Test shall be of 2 (two) hours duration for 100 marks and the qualifying mark shall be 40% thereof. Those candidates who qualify the Written Test shall attend the Interview. The interview shall be of 50 marks and the qualifying mark is 40% thereof. The marks secured by the candidates in the Written Test shall be added to the marks secured by them in the Interview to arrive at the total mark and the merit list shall be prepared on the basis of such total marks.

Hence, the candidates appearing in the Written Test are to bring with them all original certificates/documentary proof in support of age, educational qualification, experience, etc. for verification.


