The Admit cards for Computer Application Test (Theory and Skill) shall be made available for downloading from 10:00 A.M. of 01.12.2025 till 07:00 A.M. of 14.12.2025. To download the e- Admit card, please visit the website of the High Court of Orissa i.e. [www.orissahighcourt.nic.in](http://www.orissahighcourt.nic.in) (Recruitment Corner → Examination Portal→ click on the tab 'Download Admit Card of Computer Application Test for recruitment to the posts of Junior Stenographer).

The Roll Numbers of the candidates who qualify in the Computer Application Test will be declared at the examination centre by 02:00 P.M. and will also be published in the Court's website. The verification of certificates/ testimonials of those candidates who qualify in the Computer Application

Test will be done soon thereafter followed by Skill Test (Shorthand & Typewriting Test) on the same day i.e. on **14.12.2025** at the same venue. No separate admit card will be issued for appearing in the Skill Test (Shorthand & Typewriting Test). The candidates are to come prepared accordingly and bring One recent passport size photograph alongwith the following original certificates/ testimonials along with a set of self-attested photocopies thereof:-

- (i) Print Copy of the online application form.
- (ii) HSC or equivalent certificate in support of age.
- (iii) Certificate of Bachelors degree from a recognised University or such other qualification equivalent thereto.
- (iv) Certificate showing adequate knowledge in Computer Application.
- (v) Certificate from a recognised institute showing a minimum speed of 80 words per minute in Shorthand and 40 words per minute in Typewriting.
- (vi) Certificate of good character from the Institution last attended, or from two persons of repute, one of whom must be a Gazetted Officer.
- (vii) Aadhaar card.
- (viii) Certificates from the competent authority indicating the category of the caste or the tribe or the class of the applicant, in case he or she belongs to the Scheduled Caste, Scheduled Tribe or SEBC who claims age relaxation and reservation under such category.
- (ix) NOC/ letter of permission from the Competent Authority for candidates working in Government offices.


