The result of the Computer Application Test shall be published by 12:30 P.M. at the venue and also in the Court's website.

Candidates those who qualify in the Computer Application Test shall appear in the Main Written Examination (Typewriting Test in English) on the same date and venue at 01:00 P.M.

The eligible candidates are advised to bring their original Aadhaar Cards along with Admit Cards for admission to the Computer Application Test. The Admit Card can be downloaded from **10:00 A.M. of 10.08.2026 till 07:00 A.M. of 19.08.2026** by visiting Court's website i.e. www.orissahighcourt.nic.in (Recruitment Corner → Examination Portal → Recruitment to the posts of Junior Grade Typist/ Data Entry Operator (Advt. No. 01/2026) → Download Admit Card for Computer Application Test).

No separate Admit Card shall be issued for the Main Written Examination (Typewriting Test in English). Candidates those who qualify in the Computer Application Test are to produce the Admit

Card of Computer Application Test for admission to the Main Written Examination (Typewriting Test in English).

There will be verification of original documents of the candidates with respect to the testimonials uploaded by them at the time of submission of Online Application, after completion of Computer Application Test.

Therefore, the candidates are to bring the following documents for the purpose of **verification on 19.08.2026:-**

1. Admit card of Computer Application Test.
2. Print out of Online Application Form along with self-attested copies of certificates uploaded during submission of the Online Application.
3. Two Passport Size colour photographs.

Documents to be produced in Original

1. Aadhaar Card.
2. HSC or equivalent certificate in support of proof of age.
3. Certificate of Bachelor's Degree from a recognised University or such other qualification equivalent thereto.
4. Certificate showing typewriting with a minimum speed of 40 words per minute in the computer.
5. Certificate of Passing PGDCA course in Computer.
6. Certificate of good character from the Institution last attended, or from two persons of repute, one of whom must be a Gazetted Officer.
7. Certificate from competent authority indicating the category of the Caste or the Tribe or the Class of the applicant. (Wherever Applicable)
8. Discharge Certificate and Affidavit (in case of Ex-Servicemen).
9. Medical Certificate or Disability Certificate (in case of PwD).
10. Copy of notification in the Odisha Gazette in support of his/her changed/ alteration/ modification of name/ surname. (Wherever Applicable).
11. No Objection Certificate / Standing Order of NOC (in case of Government Servant).

Production of Aadhaar Card as the proof of identity is mandatory. Therefore, candidates are to bring the Admit Card of Computer Application Test and original Aadhaar Card compulsorily in order to appear in the Main Written Examination (Typewriting Test in English).

Any inconsistency/ discrepancy found in the e-Admit Card be immediately brought to the notice of the Recruitment Cell of the Court between 10:00 A.M. to 05:00 P.M. on working days over phone @ 9437498780 sufficiently ahead of the date of test.

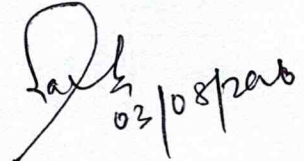
