
**DETAILS GROUND REPORT OF THE COMMITTEE CONSTITUTED,
IN VIEW OF THE DIRECTION ISSUED BY THE HON'BLE HIGH
COURT OF ORISSA AT CUTTACK, IN W.P(C) NO.18607 OF 2021, VIDE
ORDER DATED 16TH MAY, 2023.**

The DLSA, Kalahandi, in view of memo no.2261 dated 13.06.2023 received from Odisha State Legal Service Authority, in pursuance to the direction issued by the Hon'ble High Court of Orissa at Cuttack, vide order dated 16th May 2023, in the matter of Sanjiv Joshi Vs. State of Odisha, in W.P(C) No.18607 of 2021, constituted a five members Committee, which includes two Advocates and three PLVs. We, the following persons namely: - **1. Shri. Sachida Nanda Sahu, Advocate 2. Shri. Gitu Prasad Naik, Advocate 3. Shri. Saroj Kumar Dhangamajhi, PLV 4. Shri. Trilochan Gahir, PLV 5. Shri. Raghu Arakhaita Bag PLV** are included in the Committee as team member, as per office letter No-882(5) dated 19.06.2023 of the Secretary, DLSA, Kalahandi. However, one among the PLV namely Shri. Saroj Kumar Dhangamajhi was unable to join with us during course of our visit, on account of the critical illness of his family member.


The Ld. Secretary, DLSA, Kalahandi provided us all necessary documents including the order dated 16th May 2023 passed in W.P(C) No.18607 of 2021.


This Committee in order to comply the direction, started its ground visits on dated 20.06.2023, started from visiting the office of CDMO, Kalahandi to collect the list of CHCs, PHCs as well as vacancy positions of Specialists, Doctors, Pharmacists, Nursing officers, Lab-Technicians, Radiographers, Bed Strength of hospitals, Ayush M.O Strength and Detail of Works under different Schemes. It was on Dt.-22.06.2023, the Chief District Medical Officer (CDMO), provided the details, as sought for by the committee and the Committee, after verifying the documents submitted, proceeded towards the District Headquarter Hospital, Bhawanipatna Campus on the vary day.

Thereafter, we visited all 63 nos of CHCs, PHCs all over the Dist. out of 68. However, we are unable to visit PHC Dhansuli under CHC Koksara, PHC Mohangiri under CHC M.Rampur , PHC Audri under CHC Th. Rampur, PHC Jugsaipatna under CHC Borda, PHC Kandel under CHC Pastikudi and PHC Uchhla under CHC Golamunda of Kalahandi Dist. due to various other reasons like Road

Block, bandh called for by the Maoist and certain other places due to paucity of given time period.

As like our earlier visit, we further discover that position of maximum of buildings infrastructure of CHCs and PHCs are unchanged and in a dilapidated state, or having water leakages, constructed more than two decades. Also, we are informed that the staff quarters are not sufficient for the existing staffs, for which the staffs are not available around the clock at the hospital premises for the emergency requirement. On discussion with the Medical Officers of various CHCs all over the District, we came to know that injectable items, hypertension medicines and pediatrics drops and syrups are not supplied in adequate quantity, so also the homeopathy medicines. As regards the supply of Ayurvedic medicines, supplied two years back, and it is found unavailable at each and every hospital all over the districts, as stated by the Ayush M.Os.

As we enquire from Hospitals found that Specialists are as per rule available only at CHCs. On Our visit we found that in all most all CHCs there are existing vacancies of Specialists, like surgery and Medicines in all 19 CHCs. However, Specialists like O&G and Pediatric are available only in 3 to 4 CHCs. The details of vacancy positions of Specialists of all 19 CHCs is attached herewith as **Annexure-I**.

The detailed vacancies of MBBS Doctors position in Kalahandi Dist. both CHCs and PHCs, as we found still there are existing vacancies except a few positions as earlier are filled up just few days of our visit i.e. on 19.06.2023. We also came to know that some of the doctors are in study leave for their Post Graduate Study for around 3 years, hence their positions are lying vacant at various Hospitals. However, in the vacancy position annexure their positions are mentioned as filled. The detailed of vacancy position of MBBS Doctors including Specialists is attached herewith as **Annexure-II**.

We also found on our visit that Ayush M.O (Ayurvedic & Homeopathic) are also posted under NHM in various CHCs and PHCs. We found that as per their specialization, medicines like Ayurvedic & Homeopathic are not available in all the CHCs and PHCs. It is also found that the nature and duties of Ayush M.O are different to that of MBBS Doctors. However, as claim by the Hospital

Administration they are given special training (SAB) to conduct delivery, epidemic control, malaria treatment etc. as like MBBS doctors. In absence of MBBS Doctors, they are also prescribing allopathy medicines and managing the Hospitals, so also due to unavailability of the Ayurvedic and Homeo medicines. The detail of Ayush M.O posted at various CHCs and PHCs are attached herewith as ANNEXURE-III.

On our visit we enquire about the vacancy position of Nursing Officer, Pharmacist, Lab.Technicians, Radiographer. The detailed of position of Nursing Officer in CHCs and PHCs are annexed herewith as ANNEXURE-IV.

The detailed of position of Pharmacist in CHCs and PHCs are annexed herewith as ANNEXURE-V.


The detailed of position of Lab.Technicians in CHCs and PHCs are annexed herewith as ANNEXURE-VI.

The detailed of position of Radiographer in CHCs and PHCs are annexed herewith as ANNEXURE-VII.

We found at various CHCs and PHCs of the district that Nursing Officers are posted inadequate according to the total sanctioned strength of 452, position of 94 are lying vacant. Interestingly, we discover that Nursing Officers are also posted in the capacity of CHO at different sub-centers under the PHCs, but they are shown against the sanctioned strength of Nursing Officers in CHCs and PHCs. Accordingly, shortage of Nursing Officers further attributed against the actual posted strength of those Nursing Officers in CHCs and PHCs. The detailed number of CHO designated to Nursing Officers are not provided to us. It is also coming to light that those Nursing Officers, who are functioning sub-center as CHO, not performing the duties of Nursing Officer at their place of posting.

The sanctioned strength of Pharmacists in both CHCs and PHCs are 112, out of which 28 number of Pharmacists are lying vacant. As per visiting to the patients to hospitals, the sanctioned strengths are not adequate, as we feel.

The sanctioned strength of Lab.Technicians in both CHCs and PHCs are 56, out of which 26 number of Lab.Technicians posts are lying vacant. However, as per report at various CHCs and PHCs, we found that 27 numbers of Lab. Technicians are engaged under the schemes of NHM/NIDAN/CORPUS. It is needless to mentioned here that apart from these filling of sanctioned vacancies out of these

schemes, still there are requirement of Lab. Technicians in various Hospitals. If we talk about the PHCs, Lab. Technicians are either not available or they are performing duties on different days at 2 to 3 PHCs.

The sanctioned strength of Radiographer in DHH & CHCs are 19 numbers, out of which 14 numbers of Radiographer are lying vacant. However, 5 numbers of filled Radiographers are posted under NHM/NIDAN/CORPUS scheme on contractual basis. It means all sanctioned post are lying vacant, without having any sanctioned posting. As we found at various CHCs and PHCs, either machineries like X-Ray, Ultra Sound etc., are not functioning or not available.

We also came to know that Gynecologist at all most all CHCs levels in Kalahandi are not available. In the CHCs like Jaipatna, Kalampur and Koksara, pregnant women are referred to Sun Hospital, Junagarh and Agrawal Hospital, Junagarh, for ultrasound checkup in (Pradhan Mantri Surakshit Matritva Abhiyan) PMSMA Scheme, by Ambulance for which they need not to pay a penny. However, on their return, they supposed to move on their own accommodation to a distance of around 30-50Km, resultant hardship and chances of miscarriage. As like, there is availability of O&G specialist at CHC Karlamunda, however the CHC is not supplied with Ultra Sound machine, on the other hand at CHC M.Rampur, Ultra Sound Machine is available, but no O&G specialist. Accordingly, the O&G specialist move to CHC M.Rampur for 2 days in a week and all pregnant women, within the jurisdiction of CHC Karlamunda, CHC Narla and CHC M.Rampur move to CHC M.Rampur for their Ultra Sound check up, resulting hardship of around 40 k.m.

On our visit we also found that Bed Strengths of various CHCs, PHCs including DHH, Bhawanipatna and SDH, Dharmagarh are inadequate, patients are lying at floor without having bed. We able to capture videography of DHH, Bhawanipatna, which is stored in the Pen drive. ^(Annexure - XII) It also come to our knowledge that during pick rainy seasons due to increase of epidemics situation, these types of situation create, however DHH Bhawnipatna runs likely all over the year. Accordingly, Bed Strengths given as per annexures of all CHCs, PHCs including DHH, Bhawanipatna and SDH, Dharmagarh needs to increase. We also found that SRM Medical College, Bhawanipatna is not functional at present and has been

functioning with DHH, Bhawanipatna, accordingly the Bed strength recently increased from 275 to 330, but we feel, it needs further increase, so that patients lying at floor can be shifted to Bed. (Annexure - 7B XI)

As we inform during our visit that total 41 number of ambulances are functional in Kalahandi District. Out of which 108 Ambulance, 24 in numbers and 102 Ambulance, 17 in numbers. Accordingly, we feel that for a population of about 18 Lakhs in Kalahandi District, the said number of Ambulance is completely inadequate, which needs to be more than four times of present position. (Annexure - IX)

In furtherance to our visit we also found that the contractual employees including NHM/NIDAN/CORPUS are working hard in a lesser pay at the absence of regular incumbent on sanctioned post. On conversation with those contractual employees, we found that they are efficiently performing their duties and responsibilities of their respective post more than that of their regular counterpart.

Our visit further includes visitations of Building infrastructure of almost all CHCs, PHCs including DHH, Bhawanipatna and SDH, Dharmagarh. As we found maximum Sub-Centre, MCH Building and Drugs Store at SDH, Dharmagarh are under constructions and at DHH, Bhawanipatna construction of critical care Block tender to be invited, which are part of annexures marked as ANNEXURE-VIII. However, there is much more development in building infrastructure at DHH, Bhawanipatna, as compared to the earlier visit.

During our visit Hospital Administration of CHC, Junagarh including DHH, Bhawanipatna and SDH, Dharmagarh, we found that Private Medicines Stores are functioning till date at the Hospital Campus, even after the Government of Odisha circular for their eviction from Hospital Campus. On our query, the Superintendent of SDH, Dharmagarh informed that Government of Odisha circular for their eviction from Hospital Campus was Stayed by the Hon'ble Orissa High Court vide Order dated 03.11.2016, in the matter of **M/s. Meera Medicals Vs. State of Odisha being W.P.(C) No. 19266 of 2016**. This petition is till date pending adjudication before Hon'ble Orissa High Court and the Hospital Administration is helpless in this issue. We came to know that CHC Junagarh is also having the same issue in connection with W.P (C) No-20284/2016, vide Order Dated 21.11.2016. As we were informed, since medicines are distributed by the State Government free of cost

at Hospital Campus, hence such activities at the Hospital Campus needs to be restricted.

Regarding posting of Dental Surgeon (BDS), it is provision thereto post in each CHC level, however on our visit, we found in a few CHCs and the rest are lying vacant.

If posting of Medical Officers through OPSC is not possible, then at least at CDMO level, there should be some arrangements for their contractual arrangements, as many BDS and MBBS are unemployed now.

During our visit, it is also found that the hygienic situation of all hospitals, all over the District is well maintained and praise worthy, which is made possible only due to the KAYAKALP program.

During our visit, some Medical Officer suggested that:

- (a) RTA (Road Traffic Accident), CVA (Cerebro Vascular Accident), Snake Bites, OP (Organo Phosphorous) poisoning, DKA (Diabetic Keto Acidiosis), the patients are getting referred immediately to VIMSAR or other tertiary health institution, where they don't have ICU Beds, that is eventually leading to more casualties.
- (b) That, in all Medical Colleges, ICU & Ventilators are available there, but INTUBATION & MECHANICAL VENTILATION is not being done for those critical cases. If we have ventilators here, we can save the lives of those patients by intervening here, that will be a boon for many patients.
- (c) In CHCs, DHH through NIRAMAYA scheme, Medicines are being provided free for all cases like Hypertension, Diabetics etc. If for case like CKD (Chronic Kidney Disease) a monthly consultation/ Tele-Consultation can be done by a Nephrologist for follow up patients and if medicines will be provided to them free of cost, many poor patients will get the benefits, whereas DHH, Bhawanipatna is equipped with Tele-Medicine/ E-Sanjivani facility.
- (d) If medicines for rheumatology cases like Rheumatoid, Arthritis can be provided to those poor patients for of cost at DHH level, it will be beneficial for the patients.


(e) CT scan facility be provided for 24 hours in Medical Colleges and in case emergency in DHH level.

After completion of visitation to all CHCs and PHCs, all over the District, the team meet the CDMO, Kalahandi in order clarify regarding the vacancy position and the action taken thereof for filling of vacancy. On our query, the CDMO, Kalahandi stated that advertisement was published for engagement of Paramedical, as well as Class-IV category staff through the Agencies, as per Advt. No-3999, Dt.-01.11.2021, on the other hand, the process has been stayed, on the strength of the Order Dated 21.03.2023 of the Honble High Court of Orissa in W.P.(C) No-40629 of 2021.

DISTRICT HEAD QUARTER HOSPITAL(DHH), BHAWANIPATNA:


This Committee on its visit to the District Headquarter Hospital, Bhawanipatna on Dt-22.06.2023 finds vacancies of eight specialists out of total sanction strength of 27, which is part of the Annexure. It is also informed that SRM, Medical College, Bhawanipatna is not functional at present, accordingly the Professors, Additional Professors and Associate Professors appointed for that hospital are attached with the DHH, but they are not available for patient care during our visit, except only a few i.e. 2 to 3 nos. On enquiry, we found that they are not available for patient care due to unavailability of seating arrangement as per their requirement, whereas, as per the Hospital Administration, it is not possible on their part to full fill their requirement with the existing buildings, however adequate arrangement has been made for them and they are available only on call during the need hours. As we step from the main building, we accompanied by the ADMO, Medical and the Hospital Manager towards:

- a) Chemotherapy unit established for cancer patients, we found that there is no Specialist appointed for cancer patient's treatment. However, one Dr. Dinabandhu Sahu is engaged there to look after such patients, knowingly he is not a specialist of Chemotherapy, but having a special training.
- b) In MCH Building, there are Gynae patient ward, SNCU, Malnutrition with separate Children Ward. In Malnutrition, bed strength is 10 numbers, however 26

numbers of malnutrition children are admitted in an average per month, as informed, resultant there are deficiency of about 16 bed. On being asked to ADMO, Medical and the Hospital Manager, who are accompanied with us, they admitted about requirement of additional bed strength, but in the meantime reiterated that they have done temporary arrangement for that to provide adequate facility.

- c) Maternity & Child Ward: There are 48 numbers of Bed available for Gynae patients, whereas patient's strength recorded for month wise are more than 70. Similar position, we saw at the Child ward. Bed capacity is 28 and patient strength for month is 60.
- d) Cardiologist: There is no separate ward for Cardiology patient and the position of cardiologist is lying vacant, despite being shown at sanctioned strength. As we found cardiac patient's numbers are very high in the district and due to absence of treatment, such patients are forced to travel to private hospitals at Visakhapatnam, Andhrapradesh, which is around 300 Km distance from Bhawanipatna.
- e) X-Rays & CT Scan: As we found X-Rays & CT Scan machines are installed in the Hospital, which are operated by the Radiographer, but Radiologists is not available to examine the report. On enquiry we found that sanctioned strength of Radiographer in DHH are 3 in numbers, out of which 1 is in position and 2 numbers of Radiographer post are lying vacant. However, 2 numbers of Radiographers are posted under NHM/NIDAN/CORPUS scheme on contractual basis on the sanctioned post. We found long que at the diagnosis ward during our visit, which we found on enquiry that the films are being send to Spandan Diagnostic, Bhubaneswar and Krishna Diagnostic, Pune through online process, which took 1 to 6 hours to get report online. The only sanctioned post of Radiologist is vacant due to posting on deputation to Acharya Harihar Cancer Hospital, Cuttack, since long.
- f) Path Lab Test: All the tests are conducted at DHH except Thyroid Test due to lack of facilities. On enquiry we found that as a matter of stop gape arrangement blood samples are sent to Bolangir and Koraput Medical Collage, which take 2 to 3 days.
- g) Medicine Ward: The medicine ward is divided in to two division between Male and Female. In Male ward Bed strength is 38 and in Female it is 37, whereas on

the day of our visit 58 female patients were admitted and Male, also similar position, lying on floor and corridor of the ward. We feel the sanctioned Bed strength is inadequate and needs to increase.


- h) Nephrology Dialysis Ward: A Nephrology Dialysis Ward at DHH is in operational, but having no Specialist and Sanctioned post. As we saw, it is running in PPP mode with Rahi Care. Before few days, one of the family members of a patient admitted in this ward, alleged that due to improper supply of oxygen, the patient died. Accordingly, we feel it appropriate to visit this ward but, on our visit, we found that 8 numbers of filled cylinder are available for 7 numbers of bed.
- i) ICU Ward: As we saw that one ICU ward is functional having bed strength of 6 numbers and one Medicine specialist is in-charge of the same, however we feel that the bed strength is completely inadequate.
- j) We also found that several patients from neighboring district border are coming to DHH, Bhawanipatna every day, which causing gathering of patients. Accordingly, bed strengths of each department need to be increased.

However, as per compared to our earlier visit, we found that the building infrastructure and facilities are being improved only at DHH Bhawanipatna.

It was on **Dt-23.06.2023**, we proceeded further towards Kesinga and there visited CHC Pastikudi, PHC Utkela and CHC Kesinga.

CHC, Pastikudi: On our visit on Dt-23.06.2023, we found there are 4 sanctioned posts of Specialists, but except one Pediatric Specialist, all the three Specialist Posts are lying vacant. Five number of MBBS Doctors are there. The facilities like X-Ray, Ultra Sound, Path Lab Test such as Lipid Profile, R.F.T, L.F.T, Electrolyte and Thyroid are not available here, as such according to the medical officer therein, serious patient, those who are in need of such type of facilities refer to the DHH, Bhawanipatna. There are 3 M.O staff quarter available, except some quarter for Nursing Staffs, inside the Hospital Campus. There are 6 numbers of sanctioned post of Nursing Officers, but out of which two numbers of Nursing Officers posted as CHO in different Sub-Centers, resultant vacancy of 2 Nursing Officers.

PHC Utkela under CHC Pastikudi: This PHC is under CHC Kesinga. In this PHC, we noted there are 3 sanctioned post of Nursing Officer but, out of that 2 post


are lying vacant. There is no sanctioned post of Lab. Technician. However, one Lab. Technician is performing duty on contractual basis under NIDAN Scheme.

CHC Kesinga: As we found on our visit that there are 11 sanctioned post of Doctors, which include Specialists and MBBS Doctors. However, out of that, 5 posts are lying vacant. The post of two Specialist i.e. Surgery and Medicine are lying vacant since 2014. One Pediatric Specialist is posted under CORPUS. There are 18 sanctioned post of Nursing Officers, but out of that 4 are in CHO duty to different Sub-Centers. Hence, there are 4 vacancy of Nursing Officer. There are 3 sanctioned post of Lab. Technician but, only one post is filled and other two are vacant. There are only 4 staff quarter against the 11 sanctioned post of Doctors.

Thereafter it was on Dt.-24.06.2023, we visited PHC Mahichala, PHC Charbahal, CHC Koksara, PHC Ampani, PHC Ladugaon, PHC Uchhla, CHC Jaipatna, PHC Bandigaon and PHC Ranmal. The details of our visit report to these Hospitals are as under: -

PHC Mahichala under CHC Junagarh: There are one doctors i.e one MBBS doctor and Ayush doctor, post is lying vacant. Nursing Officer post is practically lying vacant against the sanctioned post of 3, because one post is vacant and other two although shown posted, but in reality, they are in the duty CHO to different Sub-Center, as such delivery cases of pregnant women are not done in this PHC. There is no sanctioned post of Lab. Technician. Accordingly, only kit tests are conducted here. The Hospital Building as of now is inadequate for PHC and the M.O. quarter is in dilapidated conditions, constructed more than decade.

PHC: Charbahal under CHC Junagarh: All the post of doctors is filled up. However, pharmacist post is lying vacant. However, as a matter of short gape arrangement Pharmacist of CHC Koksara is under deputation since, January,2022. Nursing Officer post is practically lying vacant against the sanctioned post of 3, because one post is vacant and other two although shown posted but in reality, they are in the duty CHO to different Sub-Center, as such delivery cases of pregnant women are not done in this PHC. There is no sanctioned post of Lab. Technician. However, one Lab. Technician on contractual basis in the scheme of NIDAN doing

the duty. All the staff quarters are dilapidated conditions, constructed more than decade.

CHC, Koksara: This is one of the CHCs in Kalahandi Dist. having 16 bedded capacities and about 60 K.M away from the Dist. Head Quarter. The bed capacity is inadequate, as per administration for increasement of bed strength up to 30, a request by the Hospital Administration made to the CDMO, Kalahandi. There are four specialist post of doctors and all the post are lying vacant. Out of the 11 sanctioned post of doctors 6 posts are lying vacant, out of the 5 filled posts two doctors are filled on Dt-19.06.2023. The facilities of X-Ray are there since last three months, but still sanctioned Radiographer post is lying vacant. No Ultra Sound facilities is available as like our earlier visit. There are two sanctioned post of Pharmacist, but one is under deputation to PHC, Charbahal since six months. There are seven sanctioned post of Nursing Officer, out of that 5 post are practically filled up but, one is appointed as CHO to Sub-Center and the other one is deputed to DHH, Bhawanipatna. There are two sanctioned post of Lab. Technician, but only one post is filled up and another one is on contractual basis under NIDAN Scheme. The Building infrastructure is either inadequate or dilapidated conditions, constructed more than 30 years back.

PHC Ampani under CHC Koksar: There are one sanctioned post of doctor but since, January 2023, the appointed doctor is in PG study leave. Hence, the said post is practically vacant. The only Pharmacist available at PHC is managing entire hospital in the absence of doctor. There are 3 sanctioned Nursing Officer, but 2 are filled up and one is vacant, whereas out of the 2, one is in maternity leave and another is deputed to some other hospital, as such in practically all the posts are lying vacant. No sanctioned post of Lab. Technician but one Lab. Technician is there under NIDAN scheme. However, this PHC is facilitated with Truneat Test (TB), which in fact not available even at CHC, Koksara. This PHC is established in the year 1966 whereas the M.O. quarter and other staff quarter are in a dilapidated condition having no renovation since last 20 years.

PHC Ladugaon under CHC Koksar: There are 3 sanctioned post of Nursing Officer, out of which one lying vacant. Although two post are filled up, one is employed as CHO. Accordingly, only one is in actual position. One lady Lab.

Technician being deputed from PHC, Uchhla is working under NIDAN scheme for three days in a week, in this PHC and rest of for days in other PHCs. Delivery Point is available however, no adequate facilities are there.

PHC Uchhla under CHC Jaipatna: The one sanctioned post of doctor was lying vacant since December 2022, filled up on Dt-19.06.2023 and Ayush M.O. posted here was managing the entire Hospital. There are 3 sanctioned post of Nursing Officer, but one is vacant and two others shown filled up are employed as CHO in different Sub-Center. It means all the Nursing Officer post are vacant. As such no delivery cases are undertaken in the absence of Nursing Officer. One lady Lab. Technician being posted in this PHC is working under NIDAN scheme for two days in a week and rest of the days in other PHCs. The Hospital building was constructed on 1997 and despite of several renovation, it is having problems of water leakage and in a damage condition. No M.O quarter is available here and there is no boundary wall of the Hospital campus.

CHC, Jaipatna: This is one of the CHCs in Kalahandi Dist. having 30 bedded capacities and about 75 K.M away from the Dist. Head Quarter. On our visit, we found that the bed capacities are inadequate, according to the population of dependable GPs. There are four sanctioned post of Specialist Doctors is lying vacant and out of 11 sanctioned post of doctor four are available among them two are posted recently on Dt-19.06.2023. It is needless to mentioned here that since May 2022, two doctors were managing the entire hospital. Out of them one doctor is deputed for three days in a week to DHH, Bhawanipatna. Two Pharmacist post are sanctioned, but one Pharmacist is available. There are 13 sanctioned post of Nursing Officer, out of which 10 filled up and 3 lying vacant. Whereas, as per the statement of Medical Officer In-charge, 5 numbers of Nursing Officers are in position in CHC and 4 numbers are employed as CHO in different Sub-Center. There is one sanctioned post of Lab. Technician lying vacant, but one Lab. Technician^{is} under deputation from SDH, Dharmagarh and another employed under NIDAN scheme on contractual basis in order to undertake the load factor in CHC. Facilities like X-Ray is available here and in functional condition, however, ultrasound facility is not available here, as such the pregnant women are referred to Sun Hospital, Junagarh and Agrawal Hospital, Junagarh for ultrasound checkup in

(Pradhan Mantri Surakshit Matritva Abhiyan) PMSMA Scheme by Ambulance, for which they need not to pay a penny. However, on their return they supposed to move on their own accommodation to a distance of around 52 Km from Jaipatna locality, resultant hardship and chances of miscarriage. All the Hospital buildings are years old having water leakages and in dilapidated conditions. As per Hospital Administration, one CHC building is sanctioned but yet to start construction. There are inadequate staff quarter and available Staff quarter are in a dilapidated condition. As per the Hospital Administration, due to the lack of building infrastructure/ residential facilities, no MBBS doctors are interested to join here even on contractual basis. Public Health Extension Officer (PHEO) post is also lying vacant, who conduct the I.E.C. activities for which, the work is hampered. Even the post of clerk for registration of Birth and Death is not available, accordingly one Health Worker-Male is deployed for the concern work.

PHC Bandigaon under CHC Jaipatna: The one sanctioned post of doctor is filled up and Ayush M.O. also posted here. There are 3 sanctioned post of Nursing Officer but two are vacant and one shown filled up is employed as CHO in Sub-Center. It means all the Nursing Officer post are vacant. As such no delivery cases are undertaken in the absence of Nursing Officer. No Lab. Technician and ANM are posted here. As per the Hospital Administration, request has been made several times for 6 months, despite of that, no action has been taken to depute the required staff. Only two staff quarter are available here, but in a dilapidated state, even though the newly constructed Hospital building is having problems of water leakage and in a damage condition despite of several renovation.

PHC Ranmal under CHC Jaipatna: The one sanctioned post of doctor is filled up and Ayush M.O. also posted here. There are 2 sanctioned post of Nursing Officer but two are vacant, whereas, as per hospital administration, one is available at PHC. Lab. Technician post is not sanctioned for this PHC, however one lady Lab. Technician being posted in this PHC is working under NIDAN scheme for One day in a week and rest of the days in other PHCs. The Ware House of the PHC is completely damaged and no M.O quarter or for any other staffs is available here. Further, as per the hospital administration, they are not having drinking water


facility, so also the Solar System provided to them has failed, accordingly facing problem in conducting delivery cases.

It was on Dt.-25.06.2023, we visited CHC Narla, PHC Barabandha, CHC M.Rampur, PHC Urladani, PHC Madanpur, PHC Risida, PHC Teresinga, CHC Karlamunda and PHC Regeda, PHC Belkhandi. The details of our visit report to these Hospitals are as under: -

CHC Narla: As we found on our visit that there are 11 sanctioned post of Doctors, which include Specialist and MBBS Doctors. However, out of that, all specialist posts are lying vacant and 7 are in position, as per the annexure. However, as per the Hospital Administration, one MBBS is on leave for P.G study, accordingly only 6 doctors are in actual position, among them 3 are posted on Dt-19.06.2023. Ayush M.O and 2 nos of sanctioned Pharmacist are also available here. There are 7 sanctioned post of Nursing Officer, but out of that 4 are in CHO duty to different Sub-Centers. Hence, there are 4 vacancy of Nursing Officer. There are 2 sanctioned post of Lab. Technician but, only one post is filled, however 1 Lab. Technician being posted in this PHC is working under NIDAN scheme. There are only 4 staff quarter against the 11 sanctioned post of Doctors. The available bed strength for this CHC is 6 numbers, which is not adequate for this region. All buildings of this CHC are year old, and in a dilapidated condition, including the Patient ward, Labour Room, Minor O.T complex, Administrative building, and 2 numbers of staff quarter, despite of several repairing, however only 1 BPHO building is under construction.


PHC Barabandha under CHC M.Rampur : On our visitation to this PHC, we came to know that no Govt. staff is interested to join here, being it is a remote part of Kalahandi District and as such this hospital is under the management of one NGO since June 2008, presently managed by the NGO Seba Jagat. All the sanctioned strength of MBBS Doctor, Ayush M.O and other staffs such as Pharmacist, Lab-Technician and Nursing staffs are filled up by the NGO, however all the require medicines and other infrastructure are provided by the Govt. The CHC is providing adequate health facility for that locality, as per its strength.

CHC M.Rampur: As we found on our visit that there are 11 sanctioned post of Doctors, which include Specialists and MBBS Doctors. However, out of that, all

specialist posts are lying vacant and 9 are in position, as per the annexure. However, as per the Hospital Administration, 2 MBBS are deputed to PHC Urladani and PHC Madanpur, accordingly only 7 doctors are in actual position, among them 2 are posted recently on Dt-19.06.2023. Ayush M.O and 2 nos of sanctioned Pharmacist are also filled up here. There are 13 sanctioned post of Nursing Officer, but out of that 5 are in CHO duty to different Sub-Centers, whereas out of 8 Nursing Officers, 4 are deputed to other hospitals, temporarily. Hence, there are 5 vacancy of Nursing Officer. There are 2 sanctioned post of Lab. Technician whereas, one post is lying vacant, however 1 Lab. Technician being posted in this PHC is working under NIDAN scheme on contractual basis. One sanctioned post of Radiographer post is vacant, whereas 1 Radiographer have been engaged in this CHC in the last 3 months, under NIDAN scheme on contractual basis. X-Ray machine supplied earlier in this CHC; however, it was not functional due to the unavailability of Radiographer since 2021, presently it started functioning. Ultra Sound Machine available here, but due to the vacancy of the O&G Specialist, it functions only for 2 days in a week, on visitation of O&G Specialist from CHC Karlamunda. Ayush M.O posted here just before 2 months, as such Ayush OPD is not functional. The sanctioned bed strength is 30 in this CHC, which is not adequate and needs to be increased, basing on the population density. Renovation of all buildings are going on presently, however staff quarters are not in adequate quantity.


PHC Urladani under CHC M.Rampur : The one sanctioned post of doctor is filled up here. There are 3 sanctioned post of Nursing Officer, whereas, as per hospital administration, all of them are deployed as CHO in various Sub-Centre, on the other hand, in order to manage the PHC, one is deputed from PHC Barabandha. Lab. Technician post is not sanctioned for this PHC, however one Lab. Technician being posted in this PHC is working under NIDAN scheme on contractual basis for 3 days in a week and rest of the days in other PHCs. Though, the PHC is in remote part of Kalahandi Dist., no adequate facility is available in this PHC for delivery of pregnant women. This PHC is established in the year 2012, since no staff quarter M.O is available here, even not having proper building infrastructure for OPD building.

PHC Mohangiri under CHC M.Rampur : At the time of visitation to PHC Urladani, we received information there that the Maoist has called for a bandh and has blocked the road, accordingly we were unable to move to CHC Mohangiri, however collected the information regarding this CHC, over phone from the M.O Dr. Smruti Ranjan Parimanik, having discussion with the M.O posted there. Upon discussion, we came to know that the one sanctioned post of doctor is filled up here, the Ayush M.O is also posted recently just before a month. The Pharmacist posted here is deputed to PHC Belkhandi resultant vacancy, as such one Health worker-male is performing the duty of Pharmacist, temporarily. The Lab. Technician sanctioned and shown filled up, as per annexure, whereas as per the hospital administration, he has been deputed to some other PHC, prior to 21st June 2021. There are 3 sanctioned post of Nursing Officer, whereas, as per hospital administration, all of them are deployed as CHO in various Sub-Centre. The D.P facility is available here, but functioning rarely because of deficiency of female staff nurse. The OPD building available here is inadequate. 2 numbers of M.O staff quarter are available here, whereas one is in dilapidated condition, on the other hand no other staff quarter are available. As per the hospital administration, they are in requirement of one Waiting hall & Meeting hall.

PHC Madanpur under CHC M.Rampur : One sanctioned post of doctor is filled up here, so also the Ayush M.O and sanctioned post of Pharmacist is also available in this CHC. The Lab-Technician post not sanctioned here, however one is engaged in this CHC, under NIDAN scheme on contractual basis for 3 days in a week. There are 3 sanctioned post of Nursing Officer, whereas, as per hospital administration, 2 numbers are deployed as CHO in various Sub-Centre and only one Nursing Officer is in actual position. The D.P facility is not available here. It is also found that the Hospital building is under construction, however no staff quarters are available.

PHC Risida under CHC Karlamunda : One sanctioned post of doctor is filled up recently on Dt-19.06.2023, which was lying vacant since April 2023. One Ayush M.O is also posted recently in May 2023. The sanctioned post of Pharmacist is lying vacant in this CHC, however is one Pharmacist is deputed from CHC Karlamunda since 10th June 2022. The Lab-Technician post is not sanctioned here, one was engaged in this CHC, simultaneously for PHC Teresinga, under NIDAN scheme on

contractual basis, who has left this CHC, after his regular posting, some other where and as such said post of Lab-Technician is lying vacant. There are 3 sanctioned post of Nursing Officer, whereas, as per hospital administration, 2 numbers of Nursing Officers are deployed as CHO in various Sub-Centre and only one Nursing Officer is in actual position. D.P facility is available here for pregnant women. The PHC building is not having a Lab facility and no staff quarter is available here, whereas the single staff quarter has also got damaged. As per the Hospital Administration, this PHC is not having facility of water supply, further there are no boundary wall available for the Hospital, as such the cattle are entering into the campus, creating unhygienic situation.

PHC Teresinga under CHC Karlamunda : One sanctioned post of doctor is filled up as per annexure, whereas the doctor has been deputed to CHC Karlamunda, since 2 years, as such the post of MBBS doctor is lying vacant. One Ayush M.O is also posted here and ~~was been~~ managing this PHC. As per the statement of the staff available there, the Ayush M.O met a road accident in the month of Feb 2023, since then, no doctor is available in this PHC. The sanctioned post of Pharmacist is available and has been managing this PHC. The Lab-Technician post is not sanctioned here, one was engaged in this CHC, under NIDAN scheme on contractual basis, simultaneously for PHC Risida, who has left this CHC after his regular posting, some other where and as such said post of Lab-technician is lying vacant. There are 3 sanctioned post of Nursing Officer, whereas, as per hospital administration, 2 numbers of Nursing Officers are deployed as CHO in various Sub-Centre and only one Nursing Officer is in actual position. No D.P facility is available here for pregnant women. The PHC is not having a Lab facility. As per the Hospital Administration, construction of one hospital building is completed, however, it is not handed over since long, due to certain reason not known.


CHC Karlamunda : As we found on our visit that there are 11 sanctioned post of Doctors, which include Specialists and MBBS Doctors. However, except one O&G, all specialist posts are lying vacant and 6 are in position, resultant 4 vacancy. Ayush M.O posted recently in the month of May 2023. One sanctioned strength of Pharmacist is filled up here, however the CHC required 2 more Pharamcists. There are 6 sanctioned post of Nursing Officer, but out of that 1 is in CHO duty. There

are 2 sanctioned post of Lab. Technician are filled up. One sanctioned post of Radiographer post is lying vacant, whereas X-Ray machine supplied before 6 months, however it is not functional due to the unavailability of Radiographer and for not having adequate building infrastructure. Ultra Sound Machine not available here, on the other hand the O&G Specialist is available here, who move to CHC M. Rampur for 2 days in a week, as the CHC is equipped with Ultra Sound facility. The sanctioned bed strength is 6 in this CHC, whereas two more PHCs are depending on this CHC and due to availability of O&G Specialist, here is rush of delivery patients, accordingly the bed strength is not adequate and needs to be increased, basing on the population density. The building infrastructure available at this CHC is inadequate, however one another building is under construction, on the other hand, only one M.O quarter is available against sanctioned strength of 11 doctors, further other staff quarter are also inadequate.

PHC Regeda under CHC Karlamunda : One sanctioned post of doctor is filled up. One Ayush M.O is also posted here recently in the month of June. The sanctioned post of Pharmacist is available. The Lab-Technician post is not sanctioned here, one was engaged in this CHC, under NIDAN scheme on contractual basis. There are 3 sanctioned post of Nursing Officer, whereas, all are deployed as CHO in various Sub-Centre, resultant vacancy of 3 Nursing Officer. No D.P facility is available here for pregnant women. The OPD building is having water leakage problem, despite of several repair. Out of 4 staff quarters, 3 are damaged and the land being in used for hospital is in civil dispute, accordingly, no further construction is going on. It is also found that the PHC is not having a boundary wall.

PHC Belkhandi under CHC Karlamunda : One sanctioned post of doctor is filled up. One Ayush M.O is also posted here recently before 2 months. The sanctioned post of Pharmacist is available. The Lab-Technician post is not sanctioned here and the ANM posted here is managing duty of Pharmacist, accordingly only Kit Test are conducted here. There are 3 sanctioned post of Nursing Officer, whereas, all are deployed as CHO in various Sub-Centre, resultant vacancy of 3 Nursing Officer. D.P facility is available here for pregnant women, however due to unavailability of building infrastructure, the D.P patients are

admitted at the existing Sub-Centre. The OPD building is more than 20 years, having water leakage problem, despite of several repair and presently in a risky condition. So also, all 3 staff quarters are in dilapidated condition.

It was on Dt.-26.06.2023, we visited PHC Nakarundi, CHC Th.Rampur, PHC Bandhakana, CHC kalampur, CHC Chiliguda, CHC Junagarh, PHC Kulihari and PHC Dedar. The details of our visit report to these Hospitals are as under: -


PHC Nakarundi under CHC Th.Rampur : On our visitation to this PHC, we came to know that no Govt. staff is interested to join here, being it is a remote part of Kalahandi District situated at a 55 km from dist. head quarter and as such this hospital is under the management of one NGO, presently managed by the NGO CARAM. On visitation, it is found that the MBBS Doctor posted here by the said NGO has left the service in the month of February 2023 and since then, the post is lying vacant. The Ayush M.O posted has been managing this PHC, whereas, as per the statement of the staffs, available there, the Ayush M.O is on leave since Dt-21.06.2023. The Pharmacist posted here is also on leave since a month, so also the Lab-Technician posted here was on leave on that day. There 2 sanctioned post of Nursing Officers, however only one GNM & ANM is engaged on duty by the NGO, on the other hand, all the require medicines and other infrastructure are provided by the Govt. Regarding service of delivery patient, the GNM & ANM posted here are managing the normal delivery cases and has been managing this PHC. This PHC is not having facility of Ambulance, accordingly they have only alternative to prefer the Bike ambulance from Saisurni Maa Gruha. This PHC is located in the hilly area, where all the tribal people of this locality depend on it, whereas the services provided here are inadequate. On our query, we were informed by the M.O I.C, CHC Th. Rampur that due to the poor performance of the NGO, the contract has been terminated, however due to the spread of epidemic in that locality, the agreement is extended till further order. The sanctioned bed strength is 6 in this CHC, which is not adequate. The PHC building was constructed in the year 1985 and despite of several renovation, having problem of water leakage. Staff quarter is available only for the M.O and Pharmacist and not available for the other staffs, as such rest of the employees are taking shelter at the PHC building. Being it a hilly region, the supply of electricity interrupt and telecommunication facility fails in that

locality, accordingly facing problem of availing facility Tele-Medicines and E-Sanjivani.

CHC Th.Rampur: As we found on our visit that there are 11 sanctioned post of Doctors, which include Specialists and MBBS Doctors. However, the one and only O&G specialist posted here has been deputed to DHH, Bhawanipatna, accordingly all specialist posts are lying vacant and 5 are in position, resultant 6 vacancy. Ayush M.O posted recently in the month of May 2023. One sanctioned strength of Pharmacist is filled up here, however 2 Pharmacists available here. There are 7 sanctioned post of Nursing Officer, out of that 1 is vacant and another 2 are in CHO duty, resultant 3 vacancy. There are 2 sanctioned post of Lab. Technician, out of that 1 is lying vacant, however 1 is posted on contractual basis through the NIDAN scheme. One sanctioned post of Radiographer post is lying vacant, whereas X-Ray machine is available here in this CHC, as such it is not functional due to the unavailability of Radiographer. Ultra Sound Machine is not available here. The pregnant women, in need of Ultra Sound check up are forwarded to the head quarter under PMSMA scheme, taking hardship 75 km journey. The sanctioned bed strength of 16 has been extended to 30 in this CHC, whereas is not adequate and needs to be increased, basing on the peripheral area population of the locality. In this CHC, 54 numbers of employee are available at present, whereas only 16 number of staff quarter are available, among that 8 are constructed newly and the rest are in dilapidated condition. The building infrastructure available at this CHC is inadequate, however one another building has been sanctioned for this CHC.

PHC Bandhakana under CHC Kalampur : On our visitation to this PHC, it is found that, one sanctioned post of doctor is filled up recently on Dt- 19.06.2023, which was lying vacant since June 2014, however Ayush M.O posted here was managing this PHC during that period. One sanctioned post of Pharmacist is available. The Post for Lab-Technician not sanctioned here, accordingly only Kit Test are conducted here by the Pharmacist and ANM available here. There are 3 sanctioned post of Nursing Officer, whereas, all are deployed as CHO in various Sub-Centre, resultant vacancy of 3 Nursing Officer. D.P facility is not available here for pregnant women. Overall building infrastructure is adequate, however no quarter for M.O is available here in this PHC.

CHC Kalampur: As we found on our visit that there are 11 sanctioned post of Doctors, which include Specialists and MBBS Doctors, whereas 5 nos MBBS are available here, resultant 6 vacancy. Ayush M.O posted recently in the month of May 2023. Two sanctioned strength of Pharmacist is filled up here. There are 6 sanctioned post of Nursing Officer, out of that which 1 is lying vacant, whereas there are 4 number of Nursing Officer in actual position and 1 is in CHO duty. There are 1 sanctioned post of Lab. Technician are filled up, however in addition to that 1 more is engaged through NIDAN Scheme on contractual basis. One sanctioned post of Radiographer post is lying vacant, whereas X-Ray machine supplied on Nov 2022, however it is not functional due to the unavailability of Radiographer and for not having 3 phase electric connection. On our visitation, we saw that the X-Ray machine is placed in a room, having asbestos roof, having water leakage, because of the unavailability of adequate building facility. Ultra Sound Machine not available here, as such the pregnant women are referred to Sun Hospital, Junagarh and Agrawal Hospital, Junagarh for ultrasound checkup in (Pradhan Mantri Surakshit Matritva Abhiyan) PMSMA Scheme by Ambulance for which the need not to pay a penny. However, on their return, they supposed to move on their own accommodation to a distance of around 40 Km from Kalampur locality, resultant hardship and chances of miscarriage. The sanctioned bed strength is 6 in this CHC, whereas more than 15 numbers of indoor patients per day, available here, accordingly the bed strength is not adequate and needs to be increased taking into consideration to the population density and peripheral area. As per the Hospital Administration, they have been requesting the CDMO in order to increase the bed strength since 2019 In this CHC, more than 70 number of delivery cases are conducted here. According to the Hospital Administration, the CHC is in requirement of a blood storage. As per the statement of the Lab-Technician, the grouping chemical, which is a basic need is also not supplied, despite of several indent. The building infrastructure available at this CHC is in-adequate. All the buildings are of the year 1972. However, the male ward, ware house and O.T were constructed newly, whereas these are also having problem of water leakage. It is also found that, one BPHO building is under construction, which will not suffice the need of the CHC. Two number of M.O quarter is available against sanctioned

strength of 11 doctors, which are completely damaged, whereas all the emergency staff quarters are in dilapidated state, even it is found that the staffs have covered tarpaulin over the roof of their quarters. As per the hospital administration, the land belonging to this CHC is under encroachment by the people of the locality and the administration is silent in this issue, which is also a factor for providing building infrastructure. Kalampur block is having a population of around 65000 and further some of the villages comes under Th.Rampur, Junagarh, Jaipatna & Koksara Blocks, which are adjacent to Kalampur are depending in this CHC, on the other hand no adequate facilities are available here in this CHC.


CHC Chiliguda: As per annexure, there are 10 sanctioned post of Doctors, which include Specialists and MBBS Doctors, whereas 3 doctors are in position, whereas on our visit, we found that two number of MBBS doctor along with one Dental Surgeon (BDS) and one surgery specialist on contract basis is posted here, resultant 7 vacancy. We came to know that though this one is a CHC, it is under the management and control by the CHC Junagarh, at a distance of 14 Km. One sanctioned strength of Pharmacist is filled up here. There are 3 sanctioned post of Nursing Officer, out of that which 1 is lying vacant, whereas there are 1 number of Nursing Officer in actual position and 1 is in CHO duty. There are 1 sanctioned post of Lab. Technician is vacant, 1 is engaged through CORPUS Scheme on contractual basis, performing his duty for 3 days in a week and 3 days at PHC Habaspur. This CHC is not facilitated with X-Ray and Ultra sound machine. Deliver facility for pregnant women is available here, so also the I.L.R vaccination hub. The sanctioned bed strength is 6 in this CHC. The building infrastructure available here are adequate and one another building is under construction and will be handed over to department very shortly. However, the staff's quarter are in a dilapidated state.

PHC Habaspur under CHC Junagarh: That, due to the paucity of time, we were unable to visit the PHC, however able to take information from Pharmacist posted there, by collecting the contact number from the M.O, I.C of CHC Chiliguda. The Pharmacist Sri Sashi Bhusan Khamari available there inform us the details of the PHC. One sanctioned post of doctor is filled up as per annexure, whereas the M.O of the PHC is on Study leave since December 2022, which is lying vacant since June 2014. Ayush M.O post is also sanctioned here, however lying vacant. The Post

of Lab-Technician not sanctioned here, accordingly only Kit Test are conducted here by the Pharmacist. There are 3 sanctioned post of Nursing Officer, whereas 2 are vacant, on the other hand that Nursing Officer is deployed as CHO in a sub-center, resultant vacancy of 3 Nursing Officers. D.P facility is not available here for pregnant women. Overall building infrastructure in this PHC is adequate. More than 40 patients come to this PHC for availing treatment, whereas both the M.O post are lying vacant, hence this PHC is running by the Pharmacist available there.

CHC Junagarh: On our visit to CHC Junagarh, we came to know that, as per annexure it is one CHC, whereas originally it is functioning as one Area Hospital Cum PPC (Post Partem Centre). As per annexure, the O&G specialist post is lying vacant, however one O&G specialist being deputed from CHC Borda is in position and the Pediatric Specialist post is filled up. On the other hand, Specialist like Surgery and Medicine is lying vacant, however one Surgery Specialist is engaged on contractual basis, who is performing his duty here for weekly 2 days. There are 11 sanctioned post of Doctors, which include Specialists and MBBS Doctors, whereas 7 nos MBBS are available here, resultant 4 vacancy, among which 2 are posted recently on Dt.-19.06.2023. Ayush M.O posted here is in position. Two sanctioned strength of Pharmacist is filled up here. There are 15 sanctioned post of Nursing Officer, out of that which 5 are lying vacant, whereas out of the 10 Nursing Officer, 2 number of Nursing Officer are in CHO duty. There are 3 sanctioned post of Lab. Technician, 2 are in position and 1 post is lying vacant, however in addition to that 1 more is engaged through NIDAN Scheme on contractual basis. One sanctioned post of Radiographer post is lying vacant and as such one Radiographer is engaged through CORPUS scheme, accordingly X-Ray machine supplied here is functional. Despite of availability of O&G specialist, being employed on deputation, no Ultra Sound Machine is available here, as such the pregnant women are referred to Jagan Clinic, Junagarh for ultrasound checkup as per PMSMA (Pradhan Mantri Surakshit Matritva Abhiyan) Scheme for which the need not to pay a penny. The sanctioned bed strength is 30 in this CHC, whereas the hospital administration has made arrangement of more 20 beds to facilitate the indoor patients, on the other hand supply of medicines are being done as per the sanctioned strength. Accordingly, we feel that the strength is not adequate is not adequate and

needs to be increased taking into consideration to the population density and peripheral area of this CHC. As per the Hospital Administration, this CHC is in high requirement of OPD Building, Specialist Chamber, Dental Care Unit, Yoga Centre and Extra Casualty, whereas the land available for this CHC is insufficient, as per their requirement. As per the statement of the Lab-Technician, for the Bio-chemical Test, Auto Analyzer system has got damaged, so also for Electrolyte test, no chemical supplied since long, as such the patient in requirement of such test are preferring outside. Further the Chemicals like Buffer Solution, Analyzer, and required chemical for maintenance are also not supplied properly. As regard, the availability of building infrastructure is inadequate, having only 1 M.O quarter, 4 Nursing staffs and 1 for swiper.

PHC Kulihari under CHC Junagarh: On visitation to this PHC, we came to know that one sanctioned post of doctor is filled up as per annexure, whereas the **M.O is on deputation to SDH Dharmagarh & CHC Junagarh, last since 5 years and there is none in actual position**, which is lying vacant. The Post of Lab-Technician not sanctioned here, accordingly only Kit Test are conducted here by the Pharmacist available here. There are 3 sanctioned post of Nursing Officer, whereas 2 are vacant, on the other hand that Nursing Officer is deployed as CHO in a sub-center, resultant vacancy of 3 Nursing Officers. D.P facility is not available here for pregnant women. Overall building infrastructure in this PHC is adequate. Due to the vacancy of the M.O post, this PHC is running by the Pharmacist available here. As regards the staff quarter, all 2 quarters are damaged drastically. One new hospital building is sanctioned for this CHC, however construction not started.

PHC Dedar under CHC Junagarh: That, due to the paucity of time, we were unable to visit the PHC, however able to take information from Pharmacist posted there, by collecting the contact number from the Pharmacist of PHC Kulihari. The Pharmacist Sri Basanta Kumar Bhoi of PHC Dedar available there inform us the details of the PHC. We came to know that one sanctioned post of doctor is filled up recently on Dt 19.06.2023, which was lying vacant for last two years. The Post of Lab-Technician not sanctioned here, accordingly only Malaria Kit Test is conducted here by the Pharmacist available here. There are 3 sanctioned post of Nursing Officer, whereas 2 are vacant, on the other hand that Nursing Officer is

deployed as CHO in a sub-center, resultant vacancy of 3 Nursing Officers. D.P facility is not available here for pregnant women. Overall building infrastructure in this PHC is adequate. Due to the vacancy of the M.O post, this PHC is running by the Pharmacist available here, whereas about 25 patients comes for availing treatment to this PHC.

It was on Dt.-27.06.2023, we visited PHC Karlapada, PHC Bardi, CHC Borda, PHC Artal, however collected information of PHC Uchhla. The details of our visit report to these Hospitals are as under: -

PHC Karlapada under CHC Borda: On our visitation to this PHC, it is found that, one sanctioned post of doctor is filled up, Ayush M.O posted here in the month of May 2023 is also available. One sanctioned post of Pharmacist is also in position. The Post for Lab-Technician not sanctioned here, accordingly only Kit Test are conducted here by the Pharamacist, whereas ANM & Staff Nurse are also not available here. There are 3 sanctioned post of Nursing Officer, whereas, all are deployed as CHO in various Sub-Centre, resultant vacancy of 3 Nursing Officer. D.P facility is not available here for pregnant women. Overall building infrastructure is inadequate, M.O quarter is available here but it is in a dilapidated condition and no staff quarter is available for other emergency staffs. As per hospital administration, they are in requirement of a public toilet and the land available for this PHC is insufficient.

PHC Bardi under CHC Borda: On our visitation to this PHC, it is found that, one sanctioned post of doctor is filled up, Ayush M.O posted here in is also available. One sanctioned post of Pharmacist is vacant and as such one Health worker Male of Khaliapali Sub-Center is performing the duty of pharmacist. The Post for Lab-Technician not sanctioned here, accordingly only Kit Test are conducted here by the ANM & Staff Nurse available here. There are 3 sanctioned post of Nursing Officer, 1 is filled up, whereas 2 are lying vacant, resultant vacancy of 2 Nursing Officer. D.P facility is available here for pregnant women having 2 beds strength and around 25 patients visit this PHC for availing treatment. Overall building infrastructure is inadequate and the building were constructed in the yeard 2001, which are likely to get damage. M.O quarter is not available here, however all the rest quarters are also in a dilapidated condition. As per hospital administration, the



PHC is not supplied with 3 phase electricity, as such some of the machineries are not functioning.

CHC Borda: As per annexure, there are 11 sanctioned post of Doctors, which include Specialists and MBBS Doctors, whereas 6 doctors are in position, whereas 5 posts are lying vacant. We also came to know that among the filled up MBBS doctors 4 are on engaged on contractual basis, even the M.O In-charge has been also deputed from PHC Jugsaipatna since 2 years. Ayush M.O is available here, so also Two sanctioned strength of Pharmacist is filled up here. There are 6 sanctioned post of Nursing Officer and shown as filled up as per annexure, whereas 3 Nursing Officer are in CHO duty, resultant 3 vacancy. There are 1 sanctioned post of Lab. Technician is filled up. This CHC is not facilitated with X-Ray and Ultra sound machine. One sanctioned post of Radiographer is lying vacant. The CHC is sanctioned with bed strength of 16 number, having Delivery facility for pregnant women. The building infrastructure available here are inadequate, however the OPD building is having problem of water leakage. One building is under construction and will be deliver to department shortly. However, the staff's quarter are inadequate and the available quarters are in a dilapidated state.

This CHC having a vast peripheral area. PHC Jugsaipatna is at a distance of 70 km from CHC Borda, whereas PHC Deypur and Dadpur is also at a distance of 56 km and the people of these locality depends on this CHC for availing Birth & Death Certificate, facing hardship of long journey and expenses towards travelling. Accordingly, the Hospital Administration has approached to provide an office at TB Hospital at Kamathana near Bhawanipatna i.e the central area of all PHCs, functioning under this CHC, to provide the Certificate service smoothly and to conduct the training program of ASHA Karmi's there, however no action has been taken in this regard.

PHC Artal under CHC Borda : This PHC is under the management of one NGO namely CARADA. On visitation to this PHC, it is found that all the sanctioned strength of MBBS Doctor, Ayush M.O(Homeo) and other staffs such as Pharmacist and Nursing staffs are filled up by the NGO. Though the post of Lab-Technician is not sanctioned for this PHC, as per annexure, the NGO has appointed one as Lab-Technician. All the Kit based test are conducted here, except some of the Bio

Chemical test like LFT, RFT, Electrolyte, Lipid Profile and Thyroid. This PHC is having Delivery facility for pregnant women, conducting 6-7 averagely per month. All the require medicines and other infrastructure are provided by the Govt to this PHC. Though, there is no supply of Homeopathy medicines by the Govt., the NGO has managed to provide the require medicine, so also the Allopathy medicine, despite of deficit supply of medicine such as Injectable items, Hypertension drugs etc. The OPD building available here is adequate, however the staff quarter are inadequate, on the other hand one PHC building is under construction. About 35000 people of this locality depend in this PHC and the PHC is providing adequate health facility for this locality, as per its strength.

PHC Uchhla under CHC Chapuria: That, due to the technical problem in our vehicle, we were unable to visit the PHC, however able to take information from Pharmacist posted there, by collecting the contact number from the M.O, I.C of PHC Artal. The Pharmacist Sri Jayanta Kumar Sahu available there inform us the details of the PHC. One sanctioned post of doctor is filled up recently on Dt 19.06.2023, prior to this, no MBBS doctor was available here during the 2008 to 2020. One was position from 2020 to July 2022 and subsequently it was lying vacant since July 2022. Ayush M.O post was posted here and after death of the Ayush M.O in the 2012, this post is lying vacant. The Post of Lab-Technician not sanctioned here, accordingly only Kit Test are conducted here by the Pharamacist. There are 3 sanctioned post of Nursing Officer, whereas 1 is vacant, on the other hand that 2 Nursing Officers are deployed as CHO in sub-centers, resultant vacancy of 3 Nursing Officers. D.P facility is not available here for pregnant women. As regards building infrastructure, the OPD building is in dilapidated condition despite of repairing for 3 times, having problem of broken wall and water leakage. No staff quarter is available for any of the staffs, in this PHC.

Thereafter it was on Dt.-29.06.2023, we visited PHC Farang under CHC Chapuria, CHC Chapuria, CHC Golamunda, SDH Dharmagar, PHC Kankeri under CHC Parla, PHC Tipiguda, PHC Khairpadar, CHC Parla and PHC Behera. The details of our visit report to these Hospitals are as under:

PHC Farang under CHC Chapuria: One sanctioned post of doctor i filled up recently on Dt 19.06.2023, who joined on the date of our visitation i.e Dt

29.06.2023. Prior to this, it was lying vacant since December 2022. Ayush M.O was posted here in the month of April 2023, which was also lying vacant since 2019. The sanctioned post of Pharmacist is filled up. The Post of Lab-Technician is not sanctioned here, however one is deputed from CHC Golamunda under NIDAN Scheme on contractual basis, who perform his duty here in this PHC for 2 days in a week and rest of the week, only Kit Test are conducted here by the Pharmacist. There are 3 sanctioned post of Nursing Officer, whereas 2 are vacant and only 1 is in position, resultant vacancy of 2 Nursing Officers. D.P facility is available here for pregnant women. In absence of the MBBS doctor, the patients were attended by the Pharmacist and Nursing Officer available here, earlier. The PHC provide only the OPD service, however the hospital administration has arranged 6 beds to provide service to the delivery patients. This PHC is situated at distance of 35^{km} from Dist. Head Quarter and 17^{km} from SDH Dharmagarh, whereas about 50 patients per day, visit this PHC for availing treatment. As regards building infrastructure, the PHC building is 30 years old one, having problem of water leakage. No staff quarter is available for any of the staffs, in this PHC.

CHC Chapuria: As we found on our visit that there are 11 sanctioned post of Doctors, which include 4 Specialists and 7 MBBS Doctors. As per annexure all specialist posts are lying vacant and 4 MBBS doctors are in position, whereas 2 doctors are in position and another 1 deputed from CHC Narla, resultant 8 vacancies. It is also found that the Ayush M.O posted here is deputed to CHC Golamunda, as such the post is lying vacant since 2 years. Beside functioning of this CHC, one ADAPT scheme is implemented through Central Govt., however that scheme is not functioning presently, accordingly, the Pharmacist of the said scheme is engaged here in this CHC. On the other hand, 1 more sanctioned post of Pharmacist is, being filled up is transferred to PHC Tipiguda, day before of our visitation. Accordingly, 1 is in actual position. There are 7 sanctioned post of Nursing Officer, out of 4 are in CHO duty, resultant 4 vacancy. There is 1 sanctioned post of Lab.- Technician filled up, however one another is on duty, posted under NVBDCP(Malaria Program) on regular basis. One sanctioned post of Radiographer post is lying vacant. X-Ray and Ultra Sound Machine are not available here. The pregnant women, in need of Ultra Sound check up are forwarded

to Dharmagarh under PMSMA scheme. The sanctioned bed strength for this CHC is 16 and as per hospital administration, the said strength suffices them. As per the statement of the M.O In-Charge, the path lab test, which are not possible at CHC level are conducted by the staffs of Krishna Diagnostic, after collection of samples from this CHC. The hospital building is constructed 20 years old one and having problem water leakage, got damaged and the same is inadequate for the CHC. Among the available 3 number of M.O quarters, 2 are in dilapidated condition and so also the more 7 number of emergency staff quarters. One Integrated Lab Cum BPM unit is under construction, however it will not suffice the CHC, further the boundary wall of the CHC is also incomplete. This CHC is comprising of 128 villages, having population of 145000, situated at the block head quarter Golamunda, though having no adequate facility.

PHC Mahaling under CHC Chapuria: That, due to the paucity of time, we were unable to visit this PHC, however able to take information from the M.O, I.C of CHC Chapuria. As per statement of M.O, I.C of CHC Chapuria, this PHC started functioning from 2 years and as such, it is functioning at Rajiv Gandhi Suchana Kendra of Mahaling Gram Panchayat, temporarily. However, construction of New PHC Building is in progress. As per annexure, one sanctioned post of MBBS doctor is filled up, whereas we were informed that one MBBS doctor, on contractual basis has joined this PHC on 17th June 2023, prior to that, this post was lying vacant. One Health Worker Male of Sub-Center Kuhura under CHC Chapuria is deployed here to perform the duty of Pharmacist. No Pharmacist, Lab-Technician, Nursing Officer is in position of this CHC. Village Mahaling is the business hub of that locality, having around 20,000 population, who depend on this PHC, though, no action has been taken for the improvement of this PHC.

CHC Golamunda: As we found on our visit that this CHC, it is upgraded from PHC in the year 2020. Though, it has been upgraded, the infrastructure available is that of a PHC. There are 10 sanctioned post of Doctors, which include 4 Specialists, which are lying vacant and 7 MBBS Doctors are in position, among them 4 MBBS are on contractual basis. It is also found that the Ayush M.O posted here in this CHC. As per annexure, one sanctioned post of Pharmacist is being filled up, whereas as their needs be filled by two nos Pharmacist, being it a CHC. There are

6 sanctioned post of Nursing Officer shown as filled up, whereas 3 are in CHO duty in different sub-center, resultant 6 vacancy. There is 1 sanctioned post of Lab-Technician filled up, as per annexure, however it is found that 1 Lab-Technician is engaged under the NIDAN scheme on contractual basis, who work here for 3 days in a week and rest 3 days at PHC Farang. No instrument, other than one Microscope is available here in this CHC, accordingly only Kit Test are conducted here, though it one CHC. One sanctioned post of Radiographer post is lying vacant. X-Ray and Ultra Sound Machine are not available here. The pregnant women, in need of Ultra Sound check up are forwarded to Dharmagar under PMSMA scheme. That, only 2 beds are available here emergency, though the PHC is upgraded to CHC, no bed strength is sanctioned, till date and the CHC has no scope for treatment of indoor patients, accordingly providing only the OPD service. D.P point is available here, though no Nursing Officer are available here, as such the delivery are conducted here with the help of ANM available here. The hospital building is years old one and having problem water leakage, got damaged and the same is inadequate for the CHC, so also the ware house, however the CHC building is under construction. No M.O quarters are available here, only 2 number of E-Type attendant quarter are available, where in the MBBS doctors are adjusted. About 120 patients per day visit this CHC and 30 villages depends on it, having no adequate facility, though it a block head quarter.

SDH Dharmagarh: As we found on our visit that this Sub-Divisional Hospital, Dharmagar, all sanctioned post is of Senior Specialists. There 2 sanctioned post of O & G, which are filled up, however all other post like Surgery, Medicine, Anaesthesia, Pathology and Ophthalmologist are lying vacant against sanctioned strength of each one. One Orthopedic post filled up, however by one Junior Class-I, in place of Senior Specialist. As per the Super-in-tendent of SDH Dharmagar, the sanctioned strength of Doctors is 19 in number earlier and the same came to 30, after establishment of Trauma Care Center and against the sanctioned strength, 14 are in position and 19 are vacant, out of the 14 doctors, 5 are posted recently, even among 2 are posted on contractual basis. One sanctioned post of Pharmacist is being filled up, whereas one another is deputed from CHC Junagarh. As per annexure, there are 26 sanctioned post of Nursing Officers, out of which 6 are lying vacant,

whereas 13 are in actual position and 7 are on CHO duty in different sub-center, on the other hand 3 are on maternity leave, accordingly, it's a challenging position in order to manage the hospital, as per the Super-in-tendent. There is 3 sanctioned post of Lab.- Technician filled up, in addition to that 2 Lab-Technicians are engaged under the NIDAN scheme on contractual basis, amongst them, 1 is deputed from PHC Utkela. There are two sanctioned post of Radiographer, one post is lying vacant, however the post of Radiologist not sanctioned here. X-Ray and Ultra Sound Machine are available here and in functional condition. The bed strength is sanctioned her is 55 in number, on the other hand the hospital authority has made arrangement for 60 bed, as per their need. Surgery cases, related to the O&G only are conducted here and no for other cases, as Anesthesia doctor is not available here. In case of urgent requirement of Anesthetist, one is called for from CHC Junagarh. Against sanctioned strength of 28 staff Nurse, 6 quarters are available and other emergency staffs 10 are available, against the strength of 29 numbers, constructed newly, on the other hand other quarters are years old, constructed in the year 1966 and in a dilapidated state, whereas only 2 nos of M.O Quarters are available, which are also in dilapidated condition. The MHC building is under construction. It is also found that, the Ophthalmology Section building is completely damaged and non-functional. However, all the rest facilities are adequate.

PHC Kankeri under CHC Parla: On visitation to this PHC, it is found that 1 sanctioned post of MBBS doctor is filled up recently, who joined here on Dt 20.06.2023, prior to this this post was lying vacant since May 2022. One Ayush M.O also posted here on Dt-08.05.2023, who is now deputed to PHC Parla. This hospital was managed earlier by the Pharmacist, sanctioned here. There are 3 sanctioned post of Nursing Officers and are filled up as per annexure, whereas it is found that all are deployed in CHO duty in different sub-center and no one is in actual position, resultant 3 vacancy. No Lab-Technician post sanctioned here, accordingly only Kit test are conducted here. This PHC provide only OPD service and about 25 patients this PHC regularly and 10 villages depend on it. As regard the building Infrastructure, it is completely inadequate, though the Sector Office is available within this CHC and the training program and meeting of 4 sub-centers organized here. The M.O quarter is damaged and not in use, further no other staff



quarters are available, due to the shortage of land for this PHC. As per the hospital administration, there is network issue in this PHC, as such they are unable to provide the TELE Medicine & E-Sanjivani facility to the patients as per their requirement, further the only attendant posted here is also deputed to CHC Parla and as such it is hard on their part to manage this PHC. Due to inadequate building facility, they have adjusted two beds at the meeting hall for emergency cases.

PHC Tipiguda under CHC Parla: On visitation to this PHC, it is found that 1 sanctioned post of MBBS doctor is filled up recently Dt 19.06.2023, prior to this this post was lying vacant since Jan 2023. One Ayush M.O also posted here was managing this hospital. One post of Pharmacist, sanctioned here is filled up. There are 3 sanctioned post of Nursing Officers and are filled up as per annexure, whereas it is found that all are deployed in CHO duty in different sub-center and no one is in actual position, resultant 3 vacancy. No Lab-Technician post sanctioned here, accordingly only Kit test are conducted here, despite of availability of Lab equipment. This PHC provide only OPD service and about 45 patients visit this PHC regularly. It is one of the Delivery Point, providing service to pregnant women, conducting normal delivery cases. As regard the building Infrastructure, it is completely inadequate. The M.O quarter is damaged and not in use, though other staff quarters are available in this PHC.

PHC Khairpadar under CHC Parla: On visitation to this PHC, it is found that 1 sanctioned post of MBBS doctor is lying vacant since a year. One Ayush M.O posted here is managing this hospital. One post of Pharmacist, sanctioned here is filled up. There are 3 sanctioned post of Nursing Officers and are filled up as per annexure, whereas it is found that all are deployed in CHO duty in different sub-center and no one is in actual position, resultant 3 vacancy. No Lab-Technician post sanctioned here, accordingly only Kit test are conducted here. This PHC provide only OPD service. D. P facility is not available here for pregnant women. As regard the building Infrastructure, it is adequate in this PHC including the staff quarters, however the health service is nil due to shortage of adequate staffs.

CHC Parla: As we found on our visit that this CHC, it is upgraded from PHC in the year 2014. There are 11 sanctioned post of Doctors, which include 4 Specialists, which are lying vacant and 3 MBBS Doctors are in position, resultant 8 vacancy.

Among them 1 MBBS doctor is posted recently on Dt 19.06.2023. For the last three years, only one MBBS doctor, posted here was managing this PHC. The sanctioned Post Ayush M.O is lying vacant. As per annexure, there are 2 sanctioned post of Pharmacist being filled up, whereas as, there is only 1 is in actual position. There are 4 sanctioned post of Nursing Officer and all are in actual position. There is 1 sanctioned post of Lab.- Technician filled up, as per annexure, however it is found that 1 Lab-Technician is engaged under the NIDAN scheme on contractual basis. No post of Radiographer is sanctioned here in this CHC. X-Ray and Ultra Sound Machine are not available here. The pregnant women, in need of Ultra Sound check up are forwarded to Dharmagar. This CHC is sanctioned with 6 beds for indoor patients. D.P point is available here, providing service to pregnant women, however the critical cases are forwarded to the SDH Dharmagarh, at distance of 12 km from Parla. As regards the Building infrastructure, BPHO Cum Laboratory building is under construction, however all the rest PHC buildings are more than 30 years, two numbers of M.O quarter are in dilapidated state, whereas all the rest staff quarters are available for staffs and in good condition. The Ware house of this CHC is a newly constructed one, having water harvesting system and in a good condition. As per the hospital administration, they are in requirement of one I.L.R building, which was constructed 40 years back. This PHC is not facilitated with 3 phase electricity, accordingly some of the machine are not functioning.


PHC Behera under CHC Parla: On visitation to this PHC, it is found that 1 sanctioned post of MBBS doctor, One Ayush M.O, one post of Pharmacist is filled up. There are 3 sanctioned post of Nursing Officers, 2 are lying vacant and one Nursing officer post is filled up as per annexure, whereas it is found that the posted 1 is deployed in CHO duty, resultant 3 vacancy. No Lab-Technician post sanctioned here, accordingly only Kit test are conducted here. This PHC provide only OPD service. As regard the building Infrastructure, it is adequate in this PHC, however the M.O quarter and Pharmacist quarter available here is having problem of water leakage.

Thereafter, it was on Dt.-30.06.2023, we visited PHC Bengaon under CHC Biswanathpur, CHC Lanjigarh(2), CHC Biswanathpur, PHC Lanjigarh Road under CHC Biswanathpur, PHC Madhupur under CHC Biswanathpur, PHC Rupra Road under CHC Narla, PHC Rupra under Narla, PHC Palam under Narla, PHC Ulikupa under CHC Narla, PHC Dadpur under CHC Borda and PHC Deypur under CHC Borda. The details of our visit report to these Hospitals are as under:


PHC Bengaon under CHC Biswanathpur : On our visitation to this PHC, we came to know that no Govt. staff is interested to join here, being it is a remote part of Kalahandi District situated in hilly area and as such this hospital is under the management of one NGO since June 2008, presently managed by the NGO Seba Jagat. All the sanctioned strength of MBBS Doctor, Ayush M.O and other staffs such as Pharmacist are filled up by the NGO, however all the require medicines and other infrastructure are provided by the Govt. There are 2 sanctioned post of Nursing officer for this PHC, however 1 is posted by the NGO and another 1 is lying vacant. The CHC is providing adequate health facility for that locality, as per its strength. There is no sanctioned post of Lab-Technician in this PHC, however the NGO has posted one Lab-Technician, however no Bio-Chemical test are conducted here. D.P facility is available here in this PHC, providing service to the pregnant women. As regard the building infrastructures, the OPD building has damaged due to the water leakage and the same is also insufficient, the staff quarters available here are in dilapidated state, so also the M.O quarter. The PHC is not having a boundary wall, on its back side. More than 60 patients visit this PHC for availing treatment. Being it a hilly area, the PHC is having problem of electricity and the Solar system is not functioning properly and further having network issues, as such they are unable to provide Tele-Medicine & E-Sanjivani facility, accordingly forwarded to the CHC Biswanathpur or to CHC Lanjigarh for availing such facilities.

CHC Lanjigarh(2): As we found on our visit that this CHC, there are 10 sanctioned post of Doctors, which include 4 Specialists, which are lying vacant and 5 MBBS Doctors are in position, as per annexure, whereas there are 4 MBBS doctors are in actual position and 1 is on leave for P.G study since Jan 2023. There is 1 sanctioned post of Pharmacist being filled up, there are 5 sanctioned post of Nursing Officer,

4 are filled and 1 is lying vacant, as per annexure, whereas out of 4 Nursing Officers, 2 are in CHO duty, resultant 3 vacancy. There is 1 sanctioned post of Lab.- Technician filled up, as per annexure, however it is found that the Lab-Technician is deputed to CHC Biswanathpur, accordingly only Kit test are conducted here. No post of Radiographer is sanctioned here in this CHC. X-Ray and Ultra Sound Machine are also not available here. The pregnant women, in need of Ultra Sound check up are forwarded to Vedanta Hospital. at a distance 65 Km for availing such facility. This CHC is sanctioned with 6 beds for indoor patients, which is not adequate for that locality. D.P point is available here, providing service to pregnant women, however the critical cases are forwarded to the DHH Bhawanipatna at a distance 65 Km. As regards the Building infrastructure, the PHC building is more than 45 years, having water leakage, so also two numbers of M.O quarter 1 Pharmacist quarter are in dilapidated state. As per the hospital administration, during rainy season, the PHC hospital faced the water logging problem due to the improper drainage system, however no action has been taken in this regard. This PHC is not facilitated with 3 phase electricity, accordingly some of the machine are not functioning.

CHC Biswanathpur: As we found on our visit that this CHC, there are 11 sanctioned post of Doctors, which include 4 Specialists, which are lying vacant and 5 MBBS Doctors are in position, as per annexure, whereas there are 7 MBBS doctors are in actual position. However, one Specialist O&G having diploma in Gynecology is deputed from CHC Lanjigarh. There are 2 sanctioned post of Pharmacist being filled up. There are 6 sanctioned post of Nursing Officer, all are filled up as per annexure, whereas 2 are in CHO duty, resultant 2 vacancy. There are 2 sanctioned post of Lab.- Technician, 1 is filled up, as per annexure, however it is found that one Lab-Technician is engaged under NIDAN scheme on contractual basis. Only Kit test are conducted here, except a few Bio Chemical Test Hematology and CBC. No post of Radiographer is sanctioned here in this CHC. X-Ray and Ultra Sound Machine are also not available here. The pregnant women, in need of Ultra Sound check up are forwarded to Vedanta Hospital. This CHC is sanctioned with 16 beds for indoor patients, which is not adequate for that locality. D.P point is available here, providing service to pregnant women, however the

critical cases are forwarded to the DHH Bhawanipatna at a distance 65 Km. As per hospital administration, Ambulance facility is inadequate and One 1 Ambulance needs to be allotted to PHC Bengaon to facilitate the people 5 numbers of Gram Panchayat. Further, one Ambulance provided to this CHC through the LAD Fund was taken back to the DHH Bhawanipatna and as such people of this locality are facing problem. As regards the Building infrastructure, the PHC building for IPD & OPD is under construction under AMA HOSPITAL Scheme, which will suffice their need, however the 2 number of M.O Quarters and other 4 staff quarters are having water leakage, and are in dilapidated state.

PHC Lanjigarh Road under CHC Biswanathpur: On visitation to this PHC, it is found that 1 sanctioned post of MBBS doctor posted here has been deputed to CHC Narla since 27th Dec 2023 and as such the said post is lying vacant, on the other hand one Ayush M.O is posted here before 2 months has been managing this PHC, without having proper training of allopathy medicine. One post of Pharmacist is filled up. There are 3 sanctioned post of Nursing Officers, 2 are lying vacant and one Nursing officer post is filled up as per annexure, whereas it is found that the posted 1 is deployed in CHO duty, resultant 3 vacancy. No Lab-Technician post sanctioned here, accordingly only Kit test are conducted here. This PHC provide only OPD service. D.P facility is available here for pregnant women. As regard the building Infrastructure, a new building is constructed, however there is no facility for L.T Room, Labour Room and Ayush OPD accordingly, it is adequate in this PHC and the M.O quarter available here is having problem of water leakage, on the other hand, no other quarters are available for the emergency staffs.


PHC Madhupur under CHC Biswanathpur: On visitation to this PHC, it is found that 1 sanctioned post of MBBS doctor, one Ayush M.O and Pharmacist are filled up. There are 3 sanctioned post of Nursing Officers, 2 are lying vacant and one Nursing officer post is filled up as per annexure, whereas it is found that the posted 1 is deployed in CHO duty, resultant 3 vacancy. No Lab-Technician post sanctioned here, accordingly only Kit test are conducted here. This PHC provide only OPD service. D.P facility is available here for pregnant women, however not functioning due to absence of the nursing staffs. As regard the building Infrastructure, PHC building is constructed before 10 years is having problem of

water leakage and not having facility for D.P facility and not having boundary wall, accordingly, it is adequate in this PHC and the M.O quarter is not available here, on the other hand, 4 other staff quarters are available for the 4th grade staffs, being in dilapidated condition and one of that is occupied the M.O.

PHC Rupra Road under CHC Narla: On visitation to this PHC, it is found that 1 sanctioned post of MBBS doctor, one Ayush M.O and Pharmacist are filled up. However, the MBBS doctor was on training (Ultra Sound) for a period of 6 months as such the Ayush M.O and the Pharmacist was managing this hospital. There are 3 sanctioned post of Nursing Officers, all are filled up as per annexure, whereas it is found that all of them are deployed in CHO duty, resultant 3 vacancy. No Lab-Technician post sanctioned here, accordingly only Kit test are conducted here. This PHC provide only OPD service. D.P facility is available here for pregnant women, however not functioning due to absence of the nursing staffs. As regard the building Infrastructure, PHC building is having problem of water leakage and due to the improper drainage system, the PHC building become water logged during rainy season. Further the building facility also inadequate, due to unavailability of Labour Room. M.O quarter is not available here, on the other hand, all other staff quarters are in dilapidated condition.

PHC Rupra under CHC Narla: On visitation to this PHC, it is found that 1 sanctioned post of MBBS doctor is filled up, however he has been deputed to CHC Narla since 4 months, accordingly there is no one in actual position. one Ayush M.O and Pharmacist are filled up. There are 3 sanctioned post of Nursing Officers, all are filled up as per annexure, whereas it is found that only 1 has joined here, who has been deputed to CHC Narla, resultant 3 vacancy. No Lab-Technician post sanctioned here, accordingly only Kit test are conducted here, however as per the statement of the Pharmacist, sugar testing Kit is not supplied since 1 year. Simultaneously, the Pharmacist stated that the Ayush M.O is not regular on his duty, who comes only 1 or 2 days, in a week and as such he has to manage the PHC lonely, in absence of the M.O. This PHC provide only OPD service. D.P facility is available here for pregnant women, however not functioning due to absence of the nursing staffs. As regard the building Infrastructure, PHC building is constructed in year 1995, having problem of water leakage despite of several

renovation, so also all other staff quarters and due to the improper drainage system, the PHC building become water logged during rainy season. Further the building facility also inadequate, due to unavailability of Labour Room. M.O quarter is not available here, on the other hand, all other staff quarters are in dilapidated condition.

PHC Palam under CHC Narla: On visitation to this PHC, it is found that 1 sanctioned post of MBBS doctor is filled up, however he has been deputed to CHC M.Rampur since 7th June 2022, accordingly there is no one in actual position. one Ayush M.O and Pharmacist are filled up, whereas, as per the Pharmacist P. Bhawani Shankar Patra, available here, the Ayush M.O is completely irregular in his duty, who rarely visit this PHC and such he has to manage this PHC lonely. There are 3 sanctioned post of Nursing Officers, all are filled up as per annexure, whereas it is found that all are in CHO duty, resultant 3 vacancy. No Lab-Technician post sanctioned here, accordingly only Kit test are conducted here. This PHC provide only OPD service. D.P facility is available here for pregnant women, however not functioning due to absence of the nursing staffs. As regard the building Infrastructure, PHC building is inadequate, despite of availability of sufficient area. Only M.O quarter is available, but not having facility of water supply and toiletry facility, it is not in use, on the other hand no other staff quarters available here.

PHC Ulikupa under CHC Narla: On visitation to this PHC, it is found that 1 sanctioned post of MBBS doctor is filled up, however he has been deputed to PHC Madanpur for about 3 months, accordingly there is no one in actual position. one Ayush M.O and Pharmacist are filled up. There are 3 sanctioned post of Nursing Officers, all are filled up as per annexure, whereas, it is found that all are in CHO duty, resultant 3 vacancy. No Lab-Technician post sanctioned here, accordingly only Kit test (Malaria) is conducted here and no other tests are available here. This PHC provide only OPD service. D.P facility is not available here for pregnant women. As regard the building Infrastructure, PHC building is completely damaged, having life risk to sit here, though it is constructed in the year 2011. The boundary wall is also damaged. However, the staff quarters are under construction.


PHC Dadapur under CHC Borda: On visitation to this PHC, it is found that 1 sanctioned post of MBBS doctor is filled up, so also one Ayush M.O and Pharmacist are filled up. There are 3 sanctioned post of Nursing Officers, 2 are filled up as per

annexure, one is lying vacant, whereas, it is found that 2 nursing Officers are in CHO duty, resultant 3 vacancy. No Lab-Technician post sanctioned here, however 1 is engaged through NIDAN Scheme on contractual basis, who perform his duty here for 3 days in a week. This PHC provide only OPD service. D.P facility is not available here for pregnant women. As regard the building Infrastructure, PHC building is adequate. However, M.O quarter is not available and other staff quarters are also in adequate.


PHC Deypur under CHC Borda: On visitation to this PHC, it is found that 1 sanctioned post of MBBS doctor is filled up, so also one Ayush M.O and Pharmacist are filled up. There are 3 sanctioned post of Nursing Officer are filled up as per annexure, whereas it is found that all nursing Officers are in CHO duty, resultant 3 vacancy. No Lab-Technician post sanctioned here, however 1 is engaged through NIDAN Scheme on contractual basis, who perform his duty here for 3 days in a week. This PHC provide only OPD service. D.P facility is available here for pregnant women. As regard the building Infrastructure, PHC building is adequate, which was constructed in the year 1981. A new building is constructed for Labour Room and delivery patients. However, M.O quarter is available here is in dilapidated state, so also the other staff quarters.


PHC Jugsaipatna under CHC Borda: That, due to the paucity of time, we were unable to visit this PHC, however able to take information from Pharmacist posted there, by collecting the contact number from the M.O, I.C of CHC Borda. As per the statement of Pharmacist being posted there, 1 sanctioned post of MBBS doctor is filled up, so also one Ayush M.O. There are 3 sanctioned post of Nursing Officer, 1 is filled up and 2 are lying vacant, whereas it is found that in addition to that 1 Nursing officer is deputed from PHC Utkela, due to the rush at this PHC, resultant 2 vacancy. No Lab-Technician post sanctioned here, however 1 is engaged through NIDAN Scheme on contractual basis, being deputed from Junagarh, who perform his duty here regularly. This PHC provide only OPD service. D.P facility is available here for pregnant women. As regard the building Infrastructure, PHC building is inadequate, which was constructed Vedanta Alumina Ltd., as per there


