**COMPREHENSIVE
REPORT OF THE COMMITTEE CONSTITUTED, IN VIEW OF THE
DIRECTION ISSUED BY THE HON'BLE HIGH COURT OF ORISSA AT
CUTTACK, IN THE MATTER OF SANJIV JOSHI VS. STATE OF
ODISHA BEING W.P(C) NO.18607 OF 2021, VIDE ORDER DATED 07TH
SEPTEMBER, 2021.**

In view of the direction issued by the Hon'ble High Court of Orissa at Cuttack vide orders dated 07th September, 2021, in the matter of Sanjiv Joshi Vs. State of Odisha being W.P(C) No.18607 of 2021, the DLSA, Kalahandi appointed a five members Committee which include two Advocates and three PLVs. We, the following persons are included in the Committee vide Secretary, DLSA office letter No-1179(5) Dated 20.09.2021, namely: - 1. Shri.Sachida Nanda Sahu, 2. Shri. Manas Ranjan Mohanty, 3. Shri. Jayanta Kumar Biswal, 4. Shri. Ashis Sunani, 5. Shri.Shiba Bihari.

In compliance to the directions issued by the Hon'ble Orissa High Court at Cuttack, Secretary, DLSA, Kalahandi provided all necessary documents including orders dated 07th September, 2021 and 15th September, 2021 in W.P(C) No.18607 of 2021.

This Committee in order to comply the directions, started its ground visits on Dt-23.09.2021, started from District Headquarter Hospital, Bhawanipatna. Before proceed to the Hospital Campus, this Committee met Chief District Medical Officer(CDMO), Kalahandi at his office, in order to know the conditions of Hospitals in the District. The availability of COVID Testing Kits in Kalahandi District and to verify the documents submitted by the State of Odisha before the Hon'ble Orissa High Court. He assured to provide status of all Hospitals both CHCs and PHCs within a day or two. Agreed with the request of CDMO and in order to grant him some time, we proceeded towards District Headquarter Hospital, Bhawanipatna Campus.

It was on Dt-24.09.2021, the CDMO, Kalahandi handed over a copy of available bed, vacancies at various level, COVID sample collection numbers etc. at various Hospitals at Kalahandi District including District Headquarter Hospital.

We visited all most all the CHCs all over the Dist. and visited some of the PHCs and Sub-Centers, however it was not possible on our part in a short span of time to visit all the PHCs and Sub-Centers in the Dist. We are thankful to our Secretary, DLSA for granting us further time to complete our report in order to comply the direction of Hon'ble High Court of Orissa. On our visitation to some of the Sub-Centers in the villages, we came to know that almost all the sub-centers are not functional.

During our visit, we also found that a maximum of the buildings of CHCs and PHCs are in a dilapidated state, or having water leakages, constructed more

than 40 years back. Also we are informed that the staff quarters are not sufficient for the existing staffs, for which the staffs are not available around the clock at the hospital premises for the emergency requirement. On discussion with the Medical Officers of various CHCs all over the District, **we came to know that buffer, analyzer and required chemicals are not supplied by the Administration, as such the Patholab Test like serum, sodium, potassium, LFT, Lipid Profile and Thyroid Test are not being conducted at the CHCs**, accordingly the patients are bound to move towards Private Hospitals/ Path labs outside, in order to avail the facility by paying the cost from their pocket.

The detailed of vacancies of **Doctors position in Kalahandi Dist.** is attached herewith as **Annexure-I**. The detail of **Hospital Bed** is attached herewith as **Annexure-II**. The details of vacancy of **Nursing officers** in Kalahandi Dist. as on Dt-23.09.2021 is attached here with as **Annexure-III**. The details of sanctioned strength of **Pharmacist** showing vacancies is attached here with as **Annexure-IV**. The details of sanctioned strength of **Laboratory Technician** showing vacancies is attached here with as **Annexure-V**. The details of sanctioned strength of **Radiographer** showing vacancies is attached here with as **Annexure-VI**. The details of Photographs and Videos are attached here with in a Pen Drive as **Annexure-VII**.

DISTRICT HEAD QUARTER HOSPITAL, BHAWANIPATNA:

This Committee on its visit to the District Headquarter Hospital, Bhawanipatna took photographs, Videos of the Hospital. As we saw, patients are lying in the floor for treatments, at some cases patients taking treatments at the corridor of ICU, Surgery Ward and Maternity Ward having their own mat on the floor. It is also a matter of great concern that for facilities like ICU, X-ray, ECG, Lab Facilities, Urine Culture are either available for few or otherwise not available here due to non-functional of various medical equipment's. There are no facilities for MRI, Ultra Sound and Ventilator. Furthermore, there are vacancies available at almost all branches like Specialist Doctors, Pharmacists, Nursing Staff, Lab Technician and Microbiologist.

In order to answer the queries before us, raise by the Hon'ble High Court of Orissa at Cuttack, we answer accordingly on the basis of ground report: -

1. What is the extent of availability of Health facilities both Public and Private at the Kalahandi District?

PRIVATE HOSPITALS AT KALAHANDI DISTRICTS: -

There are three numbers of Private Hospitals available in Kalahandi District, one at Lanjigarh and two are at Bhawanipatna. There are no private Hospitals available in other part of District except one or two nursing home opened recently in Junagarh having limited facilities. This Committee visited two private Hospitals in Bhawanipatna namely Shree Balaji Nursing Home and Manikeswari Multi Specialty Hospital on Dt-25.09.2021.

- (1) **Shree Balaji Hospital** is a 24 Bedded Hospital having 04 Nos of Specialist like Gynecologist, Orthopedic, ENT and Surgery along with facilities like X-Ray, Endoscopy and Path lab, however there is no facility of ICU, MRI, CT Scan and Ventilator.
- (2) **Manikeswari Multi Specialty Hospital**, refused to provide any information relating the facilities, specialist and COVID Treatment/Testing.
- (3) **Vedanta Hospital, Lanjigarh:** This is a 20 bedded Hospital, constructed by the Vedanta Alumina Limited in its peripheral development scheme, for the benefit of tribal people of Lanjigarh. This Hospital is equipped with facilities of X-ray, E-CG, Ultra-sound, Lab Facilities (except Urine culture), Ambulance services etc., However, facilities like ICU, CT Scan, MRI and ventilator are not available in this Hospital. There are 03 specialists of Orthopedic, Pediatric and Medicine on regular basis, 04 number of MBBS, 01 Ayush, 01 Physiotherapist and 10 numbers of visiting doctors are engaged for treatment.

PUBLIC HOSPITALS IN KALAHANDI DISTRICT:

There are 17 numbers of CHCs and 46 numbers of PHCs and 241 numbers of Sub-Centres at village level, besides one District Hospital. As per the ground visit of this Committee to various Hospitals both CHCs and PHCs, it is found that there are number of existing vacancies of Specialist Doctors, Pharmacists, Lab Technicians, Nursing Staffs, Radiologists and other staff as well. The facilities at various CHCs and PHCs including the District Headquarter Hospital needs improvement looking into the volume of visiting patients for various diseases. The CDMO, Kalahandi in his statement before us, as well as in his report given to us, admitted the issue of shortages of staffs and facilities available at the Hospital's at Kalahandi District.

1. CHC, Koksara:

This is one of the CHCs in Kalahandi Dist. having 16 bedded capacities and about 60 K.M away from the Dist. Head Quarter having around 1,19,304 populations in the block level. The facilities like ICU, Ventilator, X-Ray, Ultra Sound, ECG are not available here, as such according to the medical officer therein, serious patient, those who are in need of such type of facilities refer to the DHH, Bhawanipatna. Even, the M.O stated that a single doctor was running the, entire CHC up to Jan 2021 for a period of two years.

2. CHC, Junagarh

This is one of the CHCs in Kalahandi Dist. having 30 bedded capacities and about 26 K.M away from the Dist. Head Quarter having around 1,81,649 populations in the block level. On our visit, we found the Medical Officer was not present, however we able to contacted him over phone through the Doctor available there and tried to know the facilities available, although he talked with us over phone, but refused to give any information. On query to the patients available at the premises, we came to know, the Medical Officer In charge is a child Specialist, running a private clinic at his resident. We saw a long que of patients attended by a single lady doctor on emergency duty at the Hospital.

3. CHC, Pastikudi

This is one of the CHCs in Kalahandi Dist. having 06 bedded capacities and about 14 K.M away from the Dist. Head Quarter under the Kesinga block. However, the people of 3 numbers of Gram Panchayat under the Sadar Block are depending on this CHC, as the GPs are far away from the CHC, Borda. We found that the bed capacities are inadequate, according to the population of dependable GPs. Even the facilities like X-ray, ECG and ultrasound are not available and Buildings are inadequate, having shortage of Specialized Doctors.

4. CHC, Biswanathpur

This is one of the CHCs in Kalahandi Dist. having 16 bedded capacities and about 45 K.M away from the Dist. Head Quarter. On our visit, we found that the bed capacities are in adequate according to the population of dependable GPs. Even the facilities like X-ray, ECG and ultrasound are not available and Buildings are inadequate, having shortage of Specialized Doctors.

5. CHC, Lanjigarh

This is one of the CHCs in Kalahandi Dist. having 06 bedded capacities and about 62 K.M away from the Dist. Head Quarter having around 93,179 populations in the block level. On our visit, we found the Chief Medical Officer was on tour, the doctor available there was asked for information, but he shows his inability to furnish any such information in absence of the Chief Medical Officer.

6. CHC, Narla

This is one of the CHCs in Kalahandi Dist. having 06 bedded capacities and about 35 K.M away from the Dist. Head Quarter having around 1,20,992 populations in the block level. On our visit, we found that the bed capacities are in adequate according to the population of dependable GPs. Even the facilities like X-ray, ECG and ultrasound are not available and Buildings are in adequate having shortage of Specialized Doctors.

7. CHC, M.Rampur

This is one of the CHCs in Kalahandi Dist. having 30 bedded capacities and about 62 K.M away from the Dist. Head Quarter having around 80,524 populations in the block level. On our visit, we found that the bed capacities are inadequate, according to the population of dependable GPs. Even the facilities like ECG and ultrasound are not available and in adequate having shortage of Specialized Doctors. The Medicine storage building is in dilapidated state and have water leakage, causing damage of such storage medicine. The X-ray Machine is there, but due to vacancy of Lab Technician, the said Machine is non-operational.

8. CHC, Karlamunda

This is one of the CHCs in Kalahandi Dist. having 06 bedded capacities and about 70 K.M away from the Dist. Head Quarter having around 57,418 populations in the block level. On our visit we found shortage of bed as per the requirement of patients. There is no facility except Path Lab. No specialized doctors and having vacancy of Dentist, the equipment use for Dental Treatment are getting damage. It is also found that Building infrastructure is insufficient and there is no staff quarter.

9. CHC, Kesinga

This is one of the CHCs in Kalahandi Dist. having 30 bedded capacities and about 35 K.M away from the Dist. Head Quarter having around 1,35,067 populations in the block level. We, on our visit found as usual and all the available medical equipment are functional.

10. CHC, Jaipatna

This is one of the CHCs in Kalahandi Dist. having 30 bedded capacities and about 75 K.M away from the Dist. Head Quarter having around 1,30,724 populations in the block level. On our visit, we found that the bed capacities are inadequate, according to the population of dependable GPs. Even the facilities like

ECG and ultrasound are not available and inadequate, having shortage of Specialized Doctors. The Hospital building is in dilapidated state and have water leakages. There are inadequate staff quarter. The vaccination was in a long que and the patient are standing outside without having temporary shade/ Tent.

11. CHC, Kalampur

This is one of the CHCs in Kalahandi Dist. having 06 bedded capacities and about 60 K.M away from the Dist. Head Quarter having around 60,075 populations in the block level. We found that the bed capacities are in adequate according to the population of dependable GPs. Even the facilities like X-ray, ECG and ultrasound are not available and Buildings are inadequate, having shortage of Specialized Doctors.

12. CHC, Chiliguda

This is one of the CHCs in Kalahandi Dist. having 06 bedded capacities and about 40 K.M away from the Dist. Head Quarter in the Junagarh block. There is no specialized Doctors against the Sanctioned Post. Two MBBS doctors are there having no specialization, who on call attend Junagarh Hospital, leaving the charge at the hand of Pharmacist. One Pharmacist is there, who carry out work in the absence of Doctors. The infrastructure is very poor in compare to the other CHCs in the District. There is no staff quarter available except some quarter for Nursing Staff, inside the Hospital Campus. There are no facilities of X-ray, Ultra-Sound, Path lab etc. Such type of require patients are being referred either to Junagarh or District Head Quarter.

13. CHC, Dharmagarh (Sub-Divisional Hospital)

This is a one of the Sub-Divisional CHCs in Kalahandi Dist. having 55 bedded capacities and about 45 K.M away from the Dist. Head Quarter having around 1,39,359 populations in the block level. On our visit, we found that the bed capacities are inadequate, according to the population of dependable GPs and having sub-division status. Even the various medical facilities are not available and inadequate. There are shortage of Specialized Doctors and the Hospital building is in dilapidated state and have water leakage. There are inadequate staff quarter and visiting patient capacity is larger in number as compare to the capacity of the Hospital.

PRIMARY HEALTH CENTRE; -

1. PHC, Bandhkana:

This is one of the PHCs in Kalahandi Dist. Under Kalampur Block at about 70 K.M away from the Dist. Head Quarter. There is one sanctioned post of Doctor, which is lying vacant since long. As we know from our visit that one Pharmacist, who carry out the responsibility of Doctor. There is Vaccination center available, but as per available patients most of the time vaccine are not available for vaccination.

2. PHC, Charbahal:

This is one of the PHCs in Kalahandi Dist. Under Junagarh Block at about 45K.M away from the Dist. Head Quarter. We, on our visit found lack of medical facilities and on query came to know that being a PHC, it depends on the CHC, Junagarh.

3. PHC, Mahichala:

This is one of the PHCs in Kalahandi Dist. Under Junagarh Block at about 45 K.M away from the Dist. Head Quarter. We, on our visit found lack of medical facilities and on query came to know that being a PHC, it depends on the CHC, Junagarh.

The other CHCs and PHCs; we are unable to visit physically due to shortage of time. However, we are able to get some data from the CDMO, Bhawanipatna which is attached along with this report as Annexure.

COVID HOSPITALS & CCCs:

On Dt-24.09.2021, this committee visited COVID Hospitals and CCC (Covid Care Centers) at Kalahandi District on the basis of number of COVID Hospitals and CCC list provided by the CDMO, Kalahandi. As per information there are two number of COVID Hospitals and four numbers of CCC at Kalahandi District. As regards two numbers of COVID Hospitals and treatment available therein COVID Hospital located at Kamthana and Govt. Engineering College, Bandhopala. Four numbers of (Covid Care Centres) CCC situated at GEC, Bandhopala, OAV Parla, OUAT and Musiguda.

On our visit to the COVID Hospitals and CCCs, we found one COVID Hospital i.e. Kamthana as usual as per the report. However, another Hospital i.e. Govt. Engineering College, Bandhopala and four numbers of (Covid Care Centre) CCC situated at GEC, Bandhopala, OAV Parla, OUAT and Musiguda are not in operational at present. As such due to non-operational of these Hospital and CCCs, we unable to check the given data and availability of facilities therein. However, COVID Hospital located at Kamthana, which is in operational till date, we found one patient taking COVID treatment and facilities are as per given data available.

2. How many RTPCR and RAT Test Kits are available in Kalahandi District?

According to the statement of the CDMO, Kalahandi as on 23.09.2021 about 6,537 RTPCR and 19,449 Antigen Test Kits are being received and the same is being distributed to the CHCs regularly. On our visit to the various CHCs and Private Hospitals, they are unable to answer about the availability of RTPCR and RAT Test Kits at their respective Hospitals. As such this Committee unable to calculate the actual figure of availability of test kits on the basis of assessment.

3. Howmany ASHA Workers or other paramedical staffs have been trained in use of RTPCR and RAT Test Kits?

This Committee found that no such training has been given to the ASHA Workers. However, they were engaged to mobilize the patients to the Testing Centers, whereas Paramedical Staffs like Pharmacists, ANM, Health Workers (Males & Females) are being trained for sample collection. However, for testing only a few are being trained, which is insufficient for a population of around 20 lakhs of the Dist. in a single testing center. The details of which is given in a table as under: -

So far as COVID Testing Lab is concern, there is only one testing Lab, available in District Head Quarter Hospital, Bhawanipatna for whole Kalahandi District.

4. What is the time lag between the taking of RTPCR and/or Rapid Antigen test in rural area and the available of result in Kalahandi District?

The time lag between the taking of RTPCR andor Rapid Antigen test in rural area is 4 to 7 days,after opening of Testing Center at the District Headquarter, Bhawanipatna. Earlier collected samples were sent to SCB Medical College, Cuttack and testing report time lag was in between 11-14 days. It is also a matter, in consideration of a single testing center at Bhawanipatna, that some of the rural areas like Jaipatna, Kalampur, Dharmagarh, Lanjigarh, Katrlamunda, M.Rampur, Th. Rampur are far away from the testing center, which is between 60-90 K.M, resultantly the time lag for these areas are around 6-7 days.

5. What is the ground reality of persons having to pay for an RTPCR and/or Rapid Antigen Test in a Private facility in an urban or a rural area and what are the statistics in this regard?

There are three numbers of Private Hospital in Kalahandi District.


I. Sri Balaji Hospital: So far as COVID treatment at this hospital is concern, it has no facilities available for COVID patients except collection of Samples for RTPCR test. As per the Hospital Authority, for collection of samples, they charged Rs.400/- from each patient, however, on a query to the patients those who took their sample collected from the said hospital, it was Rs.1200/- at the beginning and Rs.450/- at the end of pandemic second wave. On our query to the CDMO, he confirmed the amount of sample collection rate at the Private Hospital is fixed on Rs.450/-.

II. Manikeswari Multi Speciality Hospital, refused to provide any information relating to the facilities, specialist and COVID Treatment/Testing. However, on a query to the patients those who took their sample collected from the said hospital, it was Rs.1200/- at the beginning and Rs.450/- at the end of pandemic second wave.


III. Vedanta Hospital, Lanjigarh: As per the Hospital all the treatment in this Hospital are cover under the peripheral scheme and hence, no charges collected from the patient for their services including COVID sample collection. On the date of our visit 3500 Antigen Kits are available at the Hospital, but no RTPCR kits were available. Only Sample collection facility available there. No testing facility are available, For COVID Testing, collected sample are being send to the District Headquarter, Bhawanipatna. The data of collection of samples also not provided to us. As per the Hospital all the treatment in this Hospital are cover under the peripheral development scheme and no charges collected from the patient for their services including COVID sample collection.

It is needless to mentioned here that this Committee although covered various CHCs and few numbers of PHCs& Sub-Centers at village level, including Private Hospitals and COVID Hospitals& CCC, however, during short span of time it was not possible to visit each of those Hospitals in the districts. Whereas this report is exclusive and on the basis of ground reality supported by documents. Videos and Photographs attached herewith as annexures.


