That, the patient was admitted in this Institute vide Regd. No. 8458 dated 28.12.2011 at 4.45 p.m. in Neonatal Wing of New Medical Ward in critically ill condition. The mother of patient had delivered the baby by caesarian section on 25.12.2011 at 11.20 p.m. following prolonged labour at a peripheral hospital. The available information given by the father showed that the mother had Obstetric risk factors like high blood pressure, oligohydramnios, prolonged labour and premature rupture of membrane. which are risk factor for development of septicemia in the baby. The baby was treated at peripheral level for 2 days and was admitted through casualty of Sishubhawan at 4.45 p.m. dated 28.12.2011 in critically ill condition. Immediately supportive treatment was given in casualty and in neonatal wing of New Medical Ward. Unfortunately, baby developed respiratory arrest after 15 minutes of hospitalization for which she was intubated and positive pressure ventilation was given. Subsequently patient was shifted to Neonatal ICU for critical care support and the baby received all life supportive drugs, antibiotics. positive pressure ventilation and kept under closed monitoring in ICU. In spite of all efforts to save the baby, she succumed at 1.45 a.m. dated 30.12.2011 in Neonatal ICU due to septicemia and cardiac respiratory failure.
