

- The actual number of cases it has itself investigated which have resulted in a trial and conviction of the offenders."

Special Task Force (STF), Crime Branch, Odisha Police has been created by State Government in order to deal with organized crime and criminals such as Interstate drug Trafficking, Tender Fixing, Extortion and related offences, gang robbers, kidnappers/abductors for ransom, illicit supply of Arms, ammunitions and explosives, gangs involved in trade of human organs and all matters related to terrorist activity etc. having its jurisdiction throughout State of Odisha. The cases related to organized crimes are investigated at remote places of Odisha as well as beyond the State. The Wildlife Crime Cell functions under the administrative control of Additional Director General of Police, CID, Crime Branch, Cuttack. The STF, in addition to their original mandate related to investigating organized crimes, also investigate into the wildlife cases. No additional/ exclusive posts have been created for the purpose of carrying out the functions under Wildlife (Protection) Act. As per the Govt to 6 Officers in the rank order, 4 of ASI/SI/Inspector headed by an Addl. SP/DSP are part of the Wildlife Crime Cell who are entrusted with the task of investigating wildlife cases.

Apart from this, one ACF and one Forest Ranger from Forest and Environment Department are brought in deputation basis.



Initially it was presumed to be a case of poaching and a case was booked vide UD No. 03K of 2020-21. On investigation it was found to be an accidental death by a trapping net which was set for killing small wild animals and the accused person has been arrested and case has been booked in the Court of JMFC (Rural), Rourkela.
