- 7. Price quotations should be submitted only by hand or registered post addressed to the Registrar (Judicial), High Court of Orissa, Cuttack. Quotations received after last date and time of submission shall not be considered.

- 11. Authorized representatives of the bidders may remain present at 11.00 AM on 05.11.2021 for witnessing the opening of price quotations.

- 12. The Court shall take into consideration eligibility of a bidder while considering the price quotation.
- 13. The price quotation of ineligible bidders shall not be considered.
