# Invitation for Submission of Expression of Interest for Designing and Printing Annual Report of High Court of Orissa for the year-2022

The High Court of Orissa invites expression of interest (EoI) from experienced and professional agencies for designing and printing of the Annual Report of the High Court of Orissa for the year-2022.

The EoI must be submitted through offline mode (by hand or through registered post).

Tender Fee: Bids have to be submitted along with fee of ₹1000/- (non-refundable) in the shape of DD drawn on any Bank at Annexure-4, in favour of The Registrar (Judicial), High Court of Orissa, Cuttack as stipulated in Finance Department Circular No. 22857/F, Dt: 19.08.2021 in favour of The Registrar (Judicial), Orissa High Court, Cuttack.

- 1. Applicants are required to submit the following documents in hard copy either in hand or by registered post addressed to the Registrar (Judicial), High Court of Orissa, Cuttack:
  - a. Expression of Interest with signature and seal of authorized person
  - b. Documents showing similar work, if any, done in the past
  - c. Undertaking to abide by the terms and conditions of the tender notice as per Annexure 1 and the work order
  - d. Declaration with signature and seal of authorized person regarding blacklisting/non blacklisting by any organization with regard to any work in the past as per Annexure 2
  - e. Details as per Annexure 3
- 2. The last date for applying is 4<sup>th</sup> November, 2022 (during working hours). No applications or EoI received after 04.11.2022 shall be entertained.
- 3. No price quotations should be submitted at this stage.
- 4. No request for extension of time shall be allowed for completing the work.
- 5. High Court of Orissa may call for any document from any of the applicants at any stage and hold meeting(s) with all or any of the applicants for the sake of proper decision making.
- 6. The applicants should remain in readiness to showcase and submit design for the Annual Report upon short notice and upon finalization of the design, print the required number of copies of the Annual Report within the stipulated time.

- 7. Price bid shall be invited only from shortlisted candidate(s). No price bid should be submitted by any applicant without being specifically asked for the same by the Court.
- 8. The successful bidder should also be in readiness to carry out any last minute changes in the hard copy as well as digital copy of the annual report as would be desired by the Court.
- 9. The Annual Report of the Court shall be designed and created in the digital format in addition to the physical format. The applicants should have sufficient expertise and resources to design and create the Annual Report in digital format besides designing and printing the same in physical format within the stipulated time.
- 10. The raw editable design with necessary facilities to edit the same should be handed over to the Court by the successful bidder after creation of the digital copy of the Annual Report.
- 11. The lowest bidder shall be awarded with the work of designing and printing the Annual Report on such terms and condition as may be fixed in this regard by the Court.
- 12. High Court of Orissa reserves the rights to award the work order of designing and printing the Annual Report to such other applicants as it deems proper in case the 1<sup>st</sup> lowest (L1) bidder fails to complete the work in accordance with the work order.
- 13. Court shall shortlist applicants found suitable for carrying out the work.
- 14. Due to paucity of time, Court may call for price quotation of sole eligible applicant if no other applicant is found suitable for the work.
- 15. Those applicants who are found eligible shall be intimated to submit in person their price bid in sealed cover on the date and time to be fixed in this regard.
- 16. High Court of Orissa reserves the right to make any enquiry to examine the correctness of the statement made by the applicants.
- 17. All communications should be addressed to the Registrar (Judicial), High Court of Orissa, Cuttack, 753002.
- 18. Queries may be sent to the Registrar (Judicial), High Court of Orissa, Cuttack at e-mail ID-(rj.ohc-od@gov.in).
- 19. All disputes arising out of this matter shall be subject to jurisdiction of Courts at Cuttack.
- 20. Any suppression or misrepresentation of facts by any applicants shall make the bidder liable for disqualification and action according to law.

- 21. High Court of Orissa reserves the right to increase the number of copies to be designed and printed under this tender by way of corrigendum or at the time of placing purchase order. The additional order (if required), shall be provided by the successful Bidder at the same price under the same terms and conditions as in this tender.
- 22. High Court of Orissa reserves the right to amend or withdraw any of the terms and conditions mentioned as above or to reject any or all tenders without giving any notice or assigning any reason thereof.
